In the last few months, President Reagan has made a large impact on the evangelical Christian community in the United States. His speech before the National Religious Broadcasters convention was welcomed by the 40 million people in the United States who are evangelical Christians. His more recent address to the National Association of Evangelicals convention in Orlando, Florida, reinforced among the nation's Christians the belief that President Reagan stands for the moral beliefs that undergird historic Christianity.

CHRISTIANITY TODAY magazine is a biweekly publication that addresses itself to the evangelical Christian audience. It has a paid circulation of approximately 180,000. Its constituency cuts across a wide range of mainline Protestantism as well as independent Christian churches. Evangelical Christianity is not to be confused with fundamentalism, about which we read so much in the daily press.

I'm writing to request an interview with President Reagan that would be conducted by the magazine's editor, Gilbert Beers, and myself. We wish to question the President about his views on important moral issues currently before Congress, as well as his own moral beliefs as expressed in the recent speeches. Recently, our magazine conducted an interview with former President Carter, and I have enclosed a copy of that issue with this letter. I don't believe our interview with President Reagan would focus so closely on his personal faith because he has not made that a public issue as much as President Carter has. I believe we could conduct an efficient and productive interview in 45 minutes' time. The date of the interview, of course, would be at the President's convenience.

Once again, thank you for your friendship and interest in our work. We continue to support and pray for you on a regular basis.





### FREEDOM OF RELIGION . . . OR NOT?

I recently took the unusual step of signing Discharge Petition #7 in an effort to release S. 450 from the House Judiciary Committee and allow Members of the House to vote on the issue of permitting prayer in the public schools. The Senate has already approved this legislation.

While I normally support the kind of in-depth study conducted as legislation moves through the committee system of Congress, the Judiciary Committee has kept S. 450 bottled up for a year and it appears that the full House will be denied the opportunity to vote on this vital issue. This clearly thwarts the will of most House members, as evidenced by the fact that we voted in 1979 by a 255-122 margin to add language (later dropped) to the Department of Education bill permitting school prayer. House rules Fortunately, permit a committee to be discharged from jurisdiction over a bill if a majority of members - - 218 - - sign a petition calling for such action. Discharge Petition #7 currently has 150 signatures.

It seems clear to me that the Supreme Court overstepped its bounds with its 1962 decision outlawing school prayer. A practice which had existed from the very origins of public schools was suddenly ruled unconstitutional on very questionable grounds. I agree with the lone dissenter, Justice Potter Stewart, who said, "I cannot see how an 'official religion' is established by letting those who want to say a prayer say it. On the contrary, I think that to deny the wish of these schoolchildren to join in reciting this prayer is to deny them the opportunity of sharing in the spiritual heritage of our nation."

And the fact is that spiritual heritage has been part of American history

from the very beginning, from the arrival of many of our original settlers who came to the new land to escape religious persecution and to practice their religion free from interference.

Freedom of religion in America was never confused with freedom from religion...until 1962.

Practices such as providing paid chaplains of different faiths for the armed forces, placing the motto "In God We Trust" on coins and paper money, using a Bible to administer the oath of office to our President and other officials - all of these emphasize the spiritual foundations of the American nation. And never forget that each session of the House and the Senate opens with a prayer. Should our children not have the same rights as our politicians?

The school prayer provision of S. 450 would not amend the Constitution and would not mandate a single prayer for all states and localities. It would reaffirm individual states' rights to decide this highly sensitive question according to the will of their people by preventing the Supreme Court from interfering with those states which desire voluntary prayer in schools. This action is well within the constitutional responsibilities of the Congress.

The latest nationwide Gallup survey showed that 76% of the American people favor legislation to permit prayer in public schools. And it is no wonder during this time of grave difficulty in the world that people recognize the need to strengthen our spiritual heritage and reverse the inoral decline that is occurring too often among our youth. It is my hope that the House of Representatives will have the opportunity to work the will of the people in the near future and that our children will once agbe allowed a daily praye. their classrooms.

Dear Morton:

I'm sorry our respective recollections of our May 11th meeting are not in accord. I can only say that my suggestion of seeking out alternative solutions goes back to early April when I first recommended such a strategy to you and others in the White House. I don't recall saying anything which contradicted that position during our May 11th meeting or anything I've said or done since then.

I never agreed to becoming a part of an effort "committed to fighting off all attempted changes" in the President's language. I'll chalk this up to being a simple misunderstanding. But even if I did make such a commitment (which I did not) that doesn't preclude one from being flexible in strategy when conditions of the "battle" change. fact, I deeply believe that what transpired over the past few weeks makes my original suggestion ot negotiating a mutually acceptable alternative even more valid than betore.

Also, one can "fully support" a bill while recognizing it may not stand "any real chance of passage" (as we will rediscover this week on the Hatch pro-lite Amendment). Everyone recognizes that the Hatch Amendment is doomed, but that does not stop pro-lifers from fighting diligently in support of it.

Ideally, I would love to see the President's Amendment become enacted by Congress. Unfortunately, I doubt that it will be reported out of the Judiciary Committee of the Senate. However, I do believe that a Constitutional Amendment on prayer stands a very good chance of passage.

My fear is that the only amendment reported out of Committee will be the silent prayer alternative—clearly worse than none at all. My chief objective is to keep the door open for other alternatives which will achieve the goal we are all striving for.

While I am perfectly content with the President's Amendment, I do not consider it pertect or "sacred". There is plenty of room for "fine-tuning" it to bring about the type of reconciliation so desperately needed at this time.

This is one of those occasions where nothing would make me happier than for events to prove me totally wrong. Sadly, I fear that the opposite is the case.

Praying that we can achieve a crucial victory in this important cause, I remain

RE: School Prayer Leaders Meeting with President Reagan

I believe a very excellent and timely opportunity exists for us to generate positive media attention for the President's Constitutional Amendment on school prayer. Equally important, this publicity will help to generate momentum for the issue just prior to the Senate Judiciary Committee's vote on the Amendment.

Two events will occur simultaneously which will provide a perfect press opportunity for key pro-school prayer leaders to meet with the President: First, the week April 29-May 5 has been designated National Week of Prayer. There will be a number of activities during this week culminating with a major rally at the D.A.R. Constitution Hall on May 5th. Several prominent school prayer leaders will be in Washington, D.C. at this time. Second, as fate would have it, the Senate Judiciary Committee plans to hold hearings on the President's Amendment on April 29th and May Both of these events provide an excellent opportunity and justification for the President to renew his call for Congressional action on the school prayer amendment.

Most importantly, we understand that Senator Thurmond wants to move quickly on the Constitutional Amendment and report it out of committee by the end of May. couldn't be better. It is critically important that we generate the necessary public awareness and pressure for the Constitutional Amendment to get through committee and to create momentum for future Senate action.

# - Leaders Meeting With the President -

The President has already met recently with several key religious and conservative leaders on a wide range of issues. A similar meeting with school prayer leaders should be arranged. The meeting should be limited to only 8-12 people and only needs 15-20 minutes.

The press should be invited in the meeting during which: (a) the President praises the leaders for their efforts and exhorts them to fight harder for his Amendment during this critical time; and (b) the leaders will in turn praise the President for his initiative, courage and leadership on the issue and present him with an award/plaque from Project Prayer commending his efforts.

Suggested Leaders: In addition to myself as Director of Project Prayer, I recommend Dr. Robert Grant, Chairman of Christian Voice, Rev. Tim LaHaye and his wife, Beverly, Pat Robertson and/or Ted Pantaleo from the Freedom Council, Jerry Falwell, Bob Dugan of the N.A.E., et. al.. Perhaps the key Congressional sponsors of the legislation should also be invited—Rep. Tom Kindness and Senators Thurmond and Hatch. (The Project Prayer Coalition now has 126 members, including all of the above mentioned leaders).

I will contact you in a few days to discuss this idea with you in more detail and receive your reaction. Please don't hesitate to contact me in the meantime if I can be of any assistance.
