# <u>R. T. Davies</u> We Can Help the 'Prisoners' in Our Embassy

On July 13, the Senate by unanimous insent passed a bill cosponsored by 71 its members to give the status of peranent resident of the United States to resk, Siberia, with effect from June 27, 78, when they entered the U.S. Emussy in Moscow. The bill, HR 2873, we awaits action in the House.

The Reagan administration opposes ie legislation. On Oct. 2, 1979, in one his radio commentaries on current fairs, Ronald Reagan said: "Detente supposed to be a two-way street. Our heat and technology can get into ussia—why can't the Vashchenko id Chmykhalov families get out?" ut the State Department continues to llow the Carter policy—expressing mpathy, but taking no action to help ie Vashchenkos and Chmykhalovs.

The administration objects that HR 373 would create a risky precedent: it ould "reward" persons who enter - American diplomatic premises by giving them the status of permanent resident of the United States and would consequently encourage Soviet citizens who want to get out of the U.S.S.R. to "flood" the embassy.

In written replies to Americans who have inquired about the Vashchenkos and Chmykhalovs, officials of the State Department have explained that the U.S. government "neither recognizes nor practices the granting of political asylum within our diplomatic or consular premises." "However," such letters go on, "we do recognize the humanitarian obligation to provide temporary refuge in an embassy or consulate to persons in physical danger. Anyone granted such refuge . . . must leave the premises as soon as circumstances permit."

By allowing the Pentecostals to live in the embassy, two successive administrations have recognized that circumstances do not permit the Vashchenkos and Chmykhalovs to leave without risking physical danger. And there is no prospect of a change in those circumstances.

At the same time, the State Department constantly repeats that the "ultimate responsibility for the resolution of the plight of these brave individuals lies squarely with the Soviet government."

So the superpowers have created a Catch-22 around the Vashchenkos and Chmykhalovs. The Soviets say they can apply for passports only from Chernogorsk, where for 16 years—from 1962 to 1978—they strove in vain to do just that. For its part, the American government recognizes that it must grant them refuge, but disclaims any further responsibility.

Earlier this year, alarmed by the hunger strike upon which Augustina Vashchenko and her daughter, Lydia, had embarked, Reagan wrote and asked Leonid Brezhnev to let the families leave the U.S.S.R. The only publicly known response is a mocking Tass commentary of Feb. 15, calling the president's concern "absurd" and "unsavory."

According to present plans, construction of the new embassy building in Moscow should be completed in 1984. What will then become of the U.S. government's policy of "continu[ing] to allow the Pentecostals to live in the embassy"? After all, they will then have to leave the old building and the protection of the American government in order to get to the new one. The State Department acknowledges the problem, but can say only that it has "every hope of resolving this situation well before then."

Is it not time to recognize the moral responsibility the U.S. government has assumed for these people through granting them refuge in the embassy for more than four years, and to stop opposing the only possible relief now available for them?

The legislation before Congress will not secure Soviet passports and exi visas for the Vashchenkos and Chmyk halovs. That can be done only by con vincing the Soviet authorities that they lose more by not issuing them that they gain by perpetuating the present stalemate. Permanent resident status as of June 27, 1978, would raise the possibility that the Vashchenkos and Chmykhalovs could acquire Americar citizenship before the old embassy building reverts to Soviet control Would the Soviets want to see that happen or, in the face of it, would they prefer to cut their losses and let the Vashchenkos and Chymkhalovs go?



#### TALKING POINTS

#### FOR

# MEETING WITH PRO-SCHOOL PRAYER LEADERS

July 12, 1983

- -- Welcome to the White House and first let me say thank you for all the help you have given our fight to restore voluntary school prayer.
- I think we are very close to victory now if we all pull together.
- -- The status of our Voluntary Prayer Amendment is this, on Thursday, the full Senate Judiciary Committee has scheduled a mark-up session. The vote will surely be very close.
- I realize that Senator Orrin Hatch, who supports my amendment, has also put forth, as a possible alternative, a silent prayer amendment. Frankly, I don't believe we have been fighting this prayer battle for the right to remain silent. My friend, Senator Hatch, does have a valid point, though, about the need to change the original wording of our amendment.
- -- The Senate hearings and the communications I have received from many leaders have convinced me that

we can unite all supporters of school prayer only if we can end the fears that government officials will be drafting prayers for school children. Therefore, I have asked the Chairman of the Senate Judiciary Committee, Senator Thurmond, Senator Hatch and other supporters of voluntary school prayer to revise the amendment they have submitted at my request for the past two years.

- -- The change I am requesting is this: at the end of the second sentence, add this sentence -- "Nor shall the United States or any State compose the words of any prayer to be said in public schools."
- -- This wording solves the sticky problem of state-drafted prayers without endangering currently acceptable and praiseworthy practices such as inviting clergy to offer invocations at high school graduations.
- -- As revised, our amendment will assure the constitutionality of voluntary student religious groups, children voluntarily saying grace before meals, voluntary devotional periods and silent prayer periods.
- -- This is still a local option Amendment. Each state and local jurisdiction would still have the right to

permit spoken prayer, silent prayer, or no periods for prayer at all. The Federal courts would have to stay out of regulating local decisions except to make sure that no one could be required to participate in prayer and that the government could not draft prayer for use in public schools.

- -- I need your help to pass this badly needed amendment. If things go as I hope, we can convince a majority of the Senate Judiciary Committee to pass our revised Amendment this week. Then we could aim for full Senate passage in the Fall and getting the vote in the House of Representatives early next year. The first step, though, is winning in the Senate Judiciary Committee this week. I know you can help there.



Drs. McCall and Jackson return on October 24 from meetings with the Prime Minister of Japan and the Presidents of Korea, Taiwan and Sri Lanka, during which they acted as representatives of the entire Christian communities in those Asian nations. These men are the leaders of the Baptist World Alliance, one of the largest international Protestant groups in the world with an active membership in excess of 33 million. They specialize in outreach efforts, and their previous efforts have initiated close ties between American citizens and the citizens of Japan, Russia, Spain, Germany, England, Korea, Taiwan, Hong Kong, Singapore, Sri Lanka, India, Italy, Australia, Norway, Denmark, Sweden, France, Romania and Yugoslavia.

Drs. McCall and Jackson seek a meeting with the President to appraise him of their findings from their recent visit to Asia. To date, these highly regarded Protestant leaders have never been received by an American President. Dr. Jimmy Draper, President of the Southern Baptist Convention (with 13 million members, the largest U.S. Protestant denomination), a supporter of the President and key backer of many of the President's programs, called the White House to urge that the President meet with these leaders.
