Dear Mr. President,

May I as Executive Director of the Marine Corps League, and on behalf of our National Commandant, Mr. Paul Hastings, our 26,000 members and the three and a half million active, reserve, retired, former and disabled Marines, extend to The President and The First Lady the following invitation.

It is with the deepest of pride that the Marine Corps League National Headquarters and the Tucson Arizona Marine Corps League Detachment request the honor of your presence at our forthcoming 58th Annual National Convention to be held at the Marriott Hotel in Tucson, August 16 - 21, 1981. In conjunction, we are planning the largest military exhibit of hardware, software and related services necessary for the operation of the U. S. Marine Corps as it relates to the preservation of peace and national security. This exhibit will be held with the cooperation of between 70 to 100 of the largest U. S. Marine Corps defense contractors in the United States. At the moment, the Marine Corps League fully expects to exceed 90,000 square feet of exhibit space, thus making this military display, perhaps the largest ever held in the United States separate from a military reservation.

The theme of our exhibit will be most appropriately entitled, "Modern Day Marine - Force in Readiness". The full intention of this exhibit is to take our visiting dignitaries and the 75,000 to 100,000 expected to attend from the general public, through every possible phase of the Marine's daily life and to explain in full what it really takes to make him a part of the finest fighting force in the world today.

Among the reasons why the Marine Corps League wishes to hold such an exhibit in cooperation with our active duty brothers of the Corps, the most important is that we Marines of the League feel there is no greater way to reach the support needed for all our Armed Services while expressing to the public why their support of a strong national security policy is required. We are inviting 33 members of the U. S. Congress to our exhibit, all of whom are either former Marines or are at present serving in the Marine Reserve. We have asked that each of them bring at least one other member of the Congress. We further expect at least six governors to attend, approximately 100 various Arizona mayors, and at least 40 members of the Arizona State Legislature. Celebrities who are former or retired Marines should abound. Forrest Tucker, Larry Wilcox, Ed McMahon, Lee Marvin, Bo Svenson, and long time friend of Marines, Bob Hope, are all being invited. Lieutenant Colonel Gregory "Pappy" Boyington, USMC (Ret.) is also expected to attend with some of his former "Black Sheep" wingmen.

The State of Arizona and the City of Tucson have both expressed their desire to assist in seeing to it that The President and The First Lady's visit, and the exhibit, will receive both local and national television coverage.

Complimenting the Marine Corps League's National Convention and the exhibit in Tucson, will be the annual gathering of the members of the Military Order of the Purple Heart at the same time. Over 700 delegates are expected by them, and we expect many of them and their families to visit our events.

We have officially requested certain types of key equipment to be present during the exhibit through the Offices of the Commandant of the Marine Corps. Included in the 70 to 100 defense contractors expected to appear at the exhibit will be at least 40 of the top 100 in the United States and many of their corporate leaders. They will bring with them their very best in wares and personnel.

Allow us to explain our League's purpose, Mr. President. The Marine Corps League, a Congressionally chartered veterans / military organization, is comprised of Marines and former Marines. Among its purposes are to preserve the traditions and to promote the interests of the U. S. Marine Corps; to fit its members for the duties of citizenship, and to encourage them to serve as ably as citizens as they have served their nation under arms; and to aid voluntarily and to render assistance to all Marines and former Marines as well as to their widows and orphans.

Since its incorporation by an Act of Congress in 1937, the Marine Corps League has been recognized as the organization for all Marines. The League perpetuates the more-than-200-year proud tradition and spirit of the U. S. Marine Corps through the continuous association of all those who wear (or have worn) the eagle, globe and anchor. There are many valuable programs we offer daily to all Marines everywhere. Everything the League does is designed to serve our nation and U. S. Marines.

On Friday evening, August 21, 1981, the Marine Corps League will hold its Grande Banquet at the Tucson Community Center. This event will finalize the week's activities, and we fully expect to welcome slightly over 2,000 to this gala affair. Many will be dignitaries of various stature mentioned earlier in this invitation. Hundreds of active duty, Reserve, retired, former and disabled Marines and their guests, along with over 300 people representing major defense contractors will fill the hall. We will also be extending invitations to the Secretary of State and the Secretary of Defense in hopes that one of these two distinguished gentlemen will be able to appear at either the exhibit for a few hours or the banquet.

Our invitation, Mr. President, affords two possibilities for consideration: 1) a visit by the President at anytime during any of the exhibit hours on any day during the exhibit. We are certain a brief guided tour of the various displays, both military and of our defense contractors would be most enjoyable. We suggest that just prior to the exhibit tour, The President address approximately 2,000 dignitaries, corporate leaders, our members and Marines, on any subject of his choosing. 2) should The President not be able to attend the exhibits, then we respectfully request the honor of his presence as our guest speaker for the Friday night, August 21, 1981, banquet. This would take place at the Tucson Community Center. Cocktails are scheduled for 6:00 p.m. with the banquet at 7:30 p.m. Time permitting, The President would be most welcome for both the exhibit and the banquet.

Each year at its convention, the Marine Corps League presents its coveted Military Order of the Iron Mike Award. Among its recipients are Bob Hope, Senator John Warner, General Lewis Walt, USMC (Ret.), and the late John Wayne. Last year's winner was Canadian Ambassador Kenneth Taylor who aided six Americans in their escape from Iran. This year the award will be conferred upon three deserving recipients -- a first multiple award in our history -- Press Secretary James Brady, Secret Service Agent Timothy J. McCarthy and District of Columbia Police Officer Thomas Delahanty. Mrs. Brady will be invited to receive the award for Mr. Brady, and Mr. McCarthy and Mr. Delahanty, and their wives, will be invited to attend in person. In closing, Mr. President, may we suggest that your presence at these events would be deeply appreciated and emotionally felt throughout the Corps and by those who proudly claim the title, Marine. It will be a series of events well recorded and long remembered by all Leathernecks. It is well known that throughout their history, Marines have given so much and have asked for so little in return. All would be honored and thrilled with your appearance.

We trust, sir, that our letter of invitation has afforded a basis on which a favorable decision can be made. The Marine Corps League National Headquarters is prepared to supply additional information requested by your staff pertaining to specific details or arrangements, if desired.

I know that Marines everywhere join me in extending to you the very best wishes for your strength, good health, and your continued efforts to bring our country back to a firm footing economically and for a strong, healthy and internationally respected national defense program.

The Marine Corps League was created by an Act of Congress in the 1930's. We have a detachment here in Zanesville, Ohio, and this detachment has supported the MARINE CORPS recruiting program by holding rifle shoots to attract eligible young men for the service. We supply our own rifles and ammunition.

The last several years we have without success tried to contact the following department to purchase from government surplus parts and rifles for our programs but they will not even answer our requests. The Department of Civilian Marksmanship has rifles for sale to the general public out of government stores but they refuse for some reason to even acknowledge anything to do with the Marine Corps League. I personally have written 6 letters to the following address. No replys.

Since this is in the interest of the nation, I can not imagine why we can not get a reply out of this agency. The Department of Ohio, Marine Corps League is very eager to get this program underway on a state and possibly national basis but Washington just will not answer. One letter in desperation to President Reagan was answered by the Assistant Secretary of the Navy who said the program was too dangerous since the weapons might fall into the hands of terrorists. Is this guy really Secretary of the Navy? I bet he has a toy boat in his tub at night, possibly it is a rubber-ducky instead.

Please contact this agency and see if they are alive. Have them send me papers for application to qualify for purchase of rifles, targets, spare parts and ammunition as they already sell to the general public. Above all, request a copy of their correspondence so as to insure they carry out your request. Enclosed is a picture of our last rifle shoot showing new recruits being coached at the range.
