This is in reference to a matter we touched upon briefly during our phone conversation of 1 June. I mentioned further details while on the phone with Kathy Christianson today.

The purpose of the Legion of Valor in both conversations is to recognize the great gallantry of Secret Service Agent Timothy J. McCarthy, and Officer Thomas K. Delahanty of the Metropolitan Police, in their efforts to save the life of President Reagan when he was attacked on 30 March 1981. Enclosed are copies of correspondence with officials of each organization confirming that both officers risked their lives in efforts to preserve the life of our President. Clearly, each meets the basic criteria for award of the Legion of Valor Silver Cross for Valor - risk of life in saving, or attempting to save, the life of another. We are not aware of any other national action to recognize the heroism of Mr. McCarthy and Mr. Delahanty, but we would not be surprised if the Carnegie Commission takes note of their bravery.

The Legion of Valor Silver Cross for Valor was established in 1957 and was first awarded in 1959 when presentation of the first three Crosses was made to the Unknowns of World War I, World War II, and Korea. Since 1959, sixteen awards have been made, Including the awards conferred on the Unknowns, five have presented posthumously.



Dear Mr. Boyle:

Pursuant to our phone conversation of today concerning criteria for award of the Legion of Valor Silver Cross for Valor, I'm enclosing material that may be of help should the Secret Service decide to recommend Mr. James McCarthy for the decoration. The basic qualifications are simply stated; the recipient should have risked his life in an attempt to save or preserve the life of another. Mr. McCarthy's efforts at the time the President was under attack seem to meet these criteria. A recommendation describing the events, certified by a senior member of the Secret Service, would permit me to seek the concurrence of other officers of the Legion of Valor in the expectation that a Silver Cross for Valor, with proper certificate, could be presented to Mr. McCarthy at a time and place to be sedected later.

As shown in the enclosed copy of "General Orders" for April-May, 1977 (the national periodical of the Legion of Valor) the first three Legion of Valor Silver Crosses were presented to the Unknowns of World War I. World War II, and Korea. They are on display at the Tomb of the Unknown in Arlington National Commetery. Since that time the design of the Cross has been similified and a photo of the Cross now in use is enclosed. It is possible that the Metropolitan Police Department of the District of Columbia may recommend Officer Thomas Delahanty for award of the Legion of Valor Silver Cross for Valor because of his part in the defense of the President. Should this be the case, we will keep you informed.

Please let me know of your intentions in respect to this matter. We'll do our best to cooperate.

This is in reference to a recent phone conversation with Inspector James Shugart concerning criteria for award of the Legion of Valor Silver Cross for Valor during which we dimcussed the courage displayed by Officer Thomas Delahanty when President Reagen was under attack. Briefly stated, the recipient of the Cross must have risked his life in an attempt to save or preservetthe life of another. Press accounts of the conduct of Officer Delahanty at the time the President was wounded suggest that his efforts meet these criteria. A recommendation describing the eventw, certified by a senior officer of the Metropolitan Police, would permit me to seek the concurrence of other officers of the Legion of Valor in the expectation that a Silver Cross for Valor, with proper certificate, could be presented to Officer Delahanty at an appropriate time and place.

As shown in the enclosed copy of "General Orders" for April-May, 1977 (the national periodical of the Legion of Valor), the first three Legion of Valor Silver Crosses for Valor were awarded to the Unknowns of World War I, World War II, and Korea. They are on display at the Tomb of the Unknown in Arlington National Cemetery. Since that time, the design of the Cross has been simplified and a photo of the Cross now in use is enclosed. It is possible that Special Agent James McCarthy, US Secret Service, may be recommended for the Cross because of his actions on that fateful day. Should this be the case, we will keep you informed.

Please let me know of your intentions in this metter. We'll-do our best to cooperate

Dear Brigadier General Gaynor:

This is in reply to your recent correspondence requesting specific information on the sequence of events leading up to and including the assassination attempt on the life of President Reagan.

I am pleased to provide the following information to you in the hope that it will serve as a sufficient basis by which to decide on the awarding of the Legion of Valor Silver Cross to Officer Thomas K. Delahanty, of the Metropolitan Police Department.

In planning a Presidential detail, this Department often coordinates with several units of the Secret Service who have separate and distinct responsibilities, such as, traffic direction, crowd control, and physical security. One of these duties, crowd control, was the area in which Sergeant Herbert Granger, Officer Leon Swain, Officer Thomas Delahanty, and four (4) other officers were participating.

At about 10:00 a.m., the morning of March 30, 1981, Sergeant Granger and Sergeant Donald Bell met and discussed deployment of Sergeant Granger's man-power for crowd management at the Washington Hilton that afternoon where the President would be addressing the Legislative Conference of the Building and Construction Trades Department of the AFL-CIO.

At that time it was decided that one officer would be positioned over top of the V.I.P. or ballroom entrance to the Hilton and the rest of the officers, as usual in the area of the V.I.P. entrance to the Hotel for crowd control.

The motorcade arrived at the Hilton without incident. The President entered by the V.I.P. entrance, followed by the press corps that accompanied him in the motorcade.

After entering the Hotel, Sergeant Granger, Officer Swain and Delahanty, and the rest of the detail were deployed approximately on the sidewalk between the waiting spectators and press and the V.I.P. entrance. This was done in anticipation of the President's leaving the Hotel after his speech.

The stanchions and rope were appropriately positioned on the sidewalk some 30 feet from the V.I.P. entrance and just beyond a retaining wall. Therefore, all pedestrian traffic had been excluded from the immediate area of the V.I.P. entrance. An area for the press and public was established behind the stanchions and rope. It should be noted that this area is customarily reserved for both the press and the general public who may want to view the President at some distance.

There was a small crowd of spectators and reporters in this area that remained orderly and on the sidewalk, Sergeant Granger, Officer Delahanty, and the rest of the detail observed the crowd for suspicious activity and did, in fact, direct the Secret Service Agents' attention to two subjects, who were checked and determined not be a threat to the President.

Among the crowd was John W. Hinkley. But, contrary to published reports, he did nothing to attract the attention of the police or Secret Service.

At approximately 2:25 p.m., President Reagan and his party exited the Washington Hilton and walked towards the limousines, parked about 12 feet from the V.I.P. entrance. Meanwhile the press exited the Hotel via the public entrance and created confusion by rushing towards the President in an attempt to gain his attention and comments.

As the President neared the limousine, he turned and waived at a mixed crowd of spectators and press behind the roped off area. At this time the suspect, John W. Hinkley, from a crouched position fired what is believed to be six shots from a .22 caliber handgun. Hinkley was in the first row of the crowd, but still behind the ropes some 20 feet from the President.

It is difficult to determine who was shot first and what the sequence is of those individuals wounded. However, what is clear is that the reason why the President was the last to be shot from a ricochet bullet off the limousine door; the reason why the agents were able to push the President into the limousine, vacate the area, and take the President to G.W. University Hospital for emergency treatment; the reason why six shots were fired, this allowing time for apprehending and subduing the suspect was because Officer Delahanty and Special Agent Timothy McCarthy had positioned themselves directly in the line of fire between the President and the suspect. Thus both of these officers served as obstacles to Mr. Hinkley's clear line of fire to the President. The suspect was thus forced to repeatedly fire shots in his attempt to assassinate the President. Their positions subjected them to sustaining injuries meant for the President of the United States.

The total of six shots fired took a span of time of only about two seconds. Almost immediately, Sergeant Granger, Officer Swain, a civilian spectator, and several Secret Service Agents descended upon the suspect, overpowered him, and prevented any further attempt on the life of the President or additional injuries to innocent by-standers.

In considering this particular incident, the reaction of all law enforcement personnel on the scene was immediate, professional, and heroic in that there was no thought of their own self-protection. Officer Delahanty and Special Agent McCarthy placed themselves in the line of fire to protect the life of the President. Sergeant Granger and Officer Swain were among the first to reach the suspect and were willing to charge into the face of gunfire without regard for their own safety in order to subdue this potential assassin.

In conclusion, by all standards not enough can be said of these officers and the degree of bravery and unselfish devotion to duty then exhibited on the afternoon of March 30, 1981.
