Dear Mr. Blackwell:

On 31 December 1981 the Disabled Officers Association will cease operations after more than 62 years of distinguished service to the disabled officer and their dependents in all branches of our Armed Forces.

Our membership has been declining for the past several years and has now reached the point that to continue on is not feasible. The Disabled Officers Association was formed at Walter Reed Hospital in 1919, and is the second oldest veterans organization in the United States.

For years our association was in the forefront fighting for the disabled officer and his family, and while originally formed to help those who suffered crippling wounds in World War I we later expanded to include those disabled in World War II, Korea and Viet Nam.

In early November we will publish for the last time our newsletter, The Bulletin, and we would deem it a high honor if we could feature a letter from President Reagan addressed to our members commenting on our closing operations on 31 December.

If the President will be so kind as to send us a letter, please send it to the address as shown below. If possible, we would appreciate his letter by 5 October.
