Dear Mr. Deaver:

As you may know, the President has agreed to accept our annual award as "Minute Man of the Year" for 1983 based upon his strong support for National Security and the military community. However, we have been advised that it may not be possible for the President to attend our annual Banquet which will be held Wednesday evening, 23 February 1983, at the Washington Hilton Hotel. In that event, we have been advised that either the Vice President or another senior Administration official will represent President Reagan.
