PRESIDENT REAGAN ROA LIFE MEMBER

Washington, D.C., July 17 -- President Ronald Reagan became a Life Member of the Reserve Officers Association of the United States (ROA) in ceremonies at the White House today.

Presenting the Life Membership was Maj. Gen. Evan L. Hultman, newly ' elected President of the 128,000 member association, which was chartered by Congress to advise on matters of national security.

The citation conferring ROA Life Membership status on the President recognizes his "demonstrated patriotism, fidelity, and perpetual commitment to the support of a military policy for the United States that will provide adequate national security."

President Reagan, ROA member number 0452158, has had a long association with the Army Reserve, going back to 1939 when he was a sports announcer with Radio Station WHO in Des Moines, Iowa. During that time he completed the requirements for commissioning as a second lieutenant, Cavalry Reserve. He actually received the commission in the mail after he moved to Hollywood.

General Hultman, a resident of Waterloo, Iowa, is an attorney in civilian life and an Army Reservist who commands the 103d Corps Support Command (COSCOM) in Des Moines.



Dear General Roberts:

As I recall, you had a tentative appointment to meet at the White House about April 4th regarding President Reagan's ROA membership. I presume that has been postponed. As agreed, I enclose an application for President Reagan's Life Membership and my check for \$128.00. As discussed with you, our Board will decide at the next meeting what portion the Chapter will pay. In any case, I will pay the difference. Please note I did not have information for the application for date of birth, social security number, military status, and grade. I think it best that you complete those items.

I also enclose an application and check for newly commissioned 2nd Lt Roger A. Behringer. An interesting coincidence is that I had arranged for a commissioning ceremony on March 31st at the Sacramento Army Depot for Lt. Behringer. He graduated from ROTC, University of California, Berkeley, in December 1980 and had to be commissioned before going on active duty next month. The depot commander, Col. Herman L. Brooks, conducted a very impressive ceremony attended by depot officers, family and friends. As of 1630 hours, March 31st, Lt. Behringer was the newest commissioned officer in the U. S. Army. I had planned to buy his first year's membership in ROA and it seemed appropriate to me to send this application along with the one for The President.

I also enclose a copy of the March 20th letter I received from Morton Blackwell which I read to you. Please thank him for me.

Dear Governor Reagan:

Shortly after you became Governor of California, our Sacramento Chapter 51, Reserve Officers Association of the U. S., voted to present you with a paid 5-year membership in the ROA. It was my pleasant assignment to present you with your membership card in your office. I enclose a copy of the envelope in which I received your card and the note from Col. John Carlton, who was Executive Director of our National Office at that time.

I also met with you earlier when you signed a proclamation in recognition of the 60th Anniversary of the U. S. Army Reserve (copy enclosed), and later on when you signed National Defense week proclamations, and when you were our featured speaker at the Eagle Scout Recognition banquet March 28, 1974 at the Woodlake Inn.

During your second term, I made at least six attempts to get through your staff to discuss continuing your membership in ROA. You are fully entitled to membership in ROA and it was my thought that you would want to continue and pay your own dues. Five year membership dues at that time were \$40. On at least two occasions, I left a memorandum for you making this proposal. I was unsuccessful in all of my attempts and became frustrated by one of your staff members to the point I discontinued my attempts.

Now, I want to make another proposal and relate it to your campaign for the presidency. Let me first tell you that I am one of the early members and continuous supporters of your Citizens for the Republic and furthermore, that this year alone, I have made 57 cash contributions to Republican organizations or individuals. I am one of those who is "putting his money where his mouth is". Also, I want you to know there are nearly 120,000 members in ROA nationally, of which 13,200 are in California. Most members are community and business leaders with families, so we are talking about, in the range of 500,000 voters. I do <u>not</u> want to see you get an ROA membership from National Headquarters <u>after</u> you are elected president, the way Carter did. Therefore, I propose that you apply for a life membership now. All dues will be increased on October 1st, so it is a good time. Then I will match that amount with a contribution for your campaign, to CFTR, to Jesse Helm's Americans for Reagan, to the Republican National Committee, or one you indicate will do the most good.

As you and I are nearly the same age, I know which bracket you fit into for a Life Membership. The 66-70 bracket is now \$96 and goes up to \$128 on October 1st. Dues are tax deductible as a professional organization. I enclose application blanks.

I sincerely trust that you will take the action I propose. It will be good campaign strategy and very timely. Please advise me of the action you take.
