Briefing by Constantine Menges

Monday afternoon I had an exceptionally rewarding conversation with Dr. Constantine Menges of the CIA. He demonstrated to me that we are at a very crucial point with respect to Central America. If certain steps are not taken now, we will be faced with the unpleasant alternatives of sending in U.S. combat units or acquiescing to a Marxist-Leninist takeover of most of the countries of the region.

I strongly suggest that you schedule a 20 minute briefing by Constantine as soon as possible. His number is: 351-5972.

PERSECUTION OF MISKITO INDIANS

Shortly after the Sandinistas came to power, they started resettling the Miskito Indians from their traditional area along the border. They resettled them because they wanted to re-establish control over the border AND the Miskito Indians who had historically been an independent peoples. Even Somoza allowed them to maintain their own culture and traditions.

Historically the Miskito Indians HAD NOT been politically involved. They had kept to themselves. However, since many of them spoke English and were a group apart (independent) the Sandinistas decided that they had to establish their (Sandinista) control.

The entire economy and culture of the Miskito Indians was based on the river where they had lived for centuries, the decision by the Sandinistas to move them to the interior of the country, to "resettle them" totally disrupted their social and economic way of life. Therefore, 10,000 of them fled to Honduras immediately. Of the few who remained, most have now fled to Costa Rica.

PERSECUTION OF CATHOLICS

The government of Nicaragua has been harassing and to some extent attacking the Nicaraguan Catholic Church focusing their attacks on Archbishop Obando y Bravo. (Archbishop Bravo is very popular with the people of Nicaragua.) It is interesting to note that the Archbishop had openly opposed Somosa in the latter days of the Somosa government.

Archbishop Bravo has consistently stood up for religious freedom, pluralism and democracy in Nicaragua and therefore, has been the traget of Sandinista rath. Because of his refusal to accept the party line, the Sandinistas have prohibited him from appearing on TV to celebrate mass on Sundays. (Prior to this time, each Sunday either the Archbishop or a priest delegated by him had appeared on TV celebrating the mass. The Archbishop has refused to allow the government to tell him who may and who may not celebrate the mass. Because of this, the government has reacted by cancelling the televising of the mass totally.)

Last August (1982) there were some particularly serious incidents involving the Archbishop and others. Some turbas (mobs) attacked the Archbishop's representative when he was going to a church to remove some religious objects to signify that the sacrament could no longer be celebrated at that church. The Archbishop had ordered the removal of the objects because the priest of the church had refused to accept the discipline of the church and actively opposed the church and supported the Sandinistas.

Another incident involved a Catholic church school. Some teachers in the school who supported the Archbishop were forced to leave the country.

In another incident, Monsignor Caraballo, the Archbishop's spokesman was visiting an ill parishioner in downtown Managua. Some people forced their way into the home, forced the Monsignor to disrobe and then forced the Monsignor into the street where a government television crew was awaiting to film the entire event. The government claimed that the TV crew "happened to be going by" when the Monsignor who was

alleged to be having an affair with the wife of the parishioner and who was alleged to have been found in bed by the husband, was driven, naked, into the streets.

Finally, during the recent visit of the Pope the turbas (mob) began shouting "Power to the Government." These demonstrations were noted throughout the world as very rude and as having serious political overtones.

PERSECUTION OF THE PROTESTANTS

In August, 1982, the turbas seized a number of temples of Jehovahs Witnesses; Seventh Day Adventists, and the Mormons.

Although most of the temples have been returned because of the public outcry, two belonging to the Mormons and all of the Jehovahs' Witness temples are still being held. There is speculation that because the Jehovahs' Witnesses are against military service this may be a motivating factor in the government of Nicaragua not returning the temples to the Witnesses.

Dear Ms. Zeoli:

Mrs. Faith Ryan Whittlesey asked that I respond to your recent letter regarding United States policy in Central America.

Clearly we have a difference of opinion. You say you "reject the assumption that it is the right and duty of the U.S. to act forcibly because our security is threatened by movements of national liberation in Central America." I take it that your point is that you do not believe our security is threatened by the potential establishment of additional Marxist-Leninist totalitarian governments in that area, not that you dispute the right and duty of the United States to act when our security is threatened.

To aid you in understanding the President's policies for the region, I am enclosing copies of some White House Digests which contain information which may not have been available to you, as well as a copy of the President's speech to the Joint Session of Congress on April 27th.

Perhaps the most useful discussion we might have would be concerning your statement, "The empowering of totalitarian regimes by the U.S. threatens human interests in global peace, stability." As Ambassador Jeane Kirkpatrick has so often said, it is vital that we distinguish between authoritarian and totalitarian regimes. Neither is pleasant, but, in the hierarchy of evils, totalitarian regimes are significantly worse than authoritarian regimes. Right now, the Sandinista government of Nicaragua is systematically establishing a Marxist-Leninist totalitarian regime. Freedom of the press has been extinguished. The government is actively working to destabilize and overthrow the governments of several neighboring countries. Free labor unions have been suppressed and union members herded into the Sandinista labor confederations subservient to the government. Protestant churches have been harassed and preachers forced to flee the country. The Roman Catholic Archbishop has been forced to stop his customary broadcasts of religious services,

virtually all the Nicaraguan Jewish people have fled the country and the only synagogue in Managua has been taken over for a government-run youth center. There are many times the number of political prisoners than ever before in the country's history. Indigenous Indians have been forcibly removed from their homelands and are crowded into what amounts to concentration camps. The Sandinistas are currently setting up an official "block system" in which neighbors are spying on neighbors to report any lack of enthusiasm for the new regime.

The previous regime was, no doubt, unsavory, but its transgressions of human rights pale by comparison to today's awful reality in Nicaragua. Revelations from the thousands of Nicaraguans who are fleeing their homeland bring new facts to light each day.

If communist regimes are set up in all the Central American countries, there will be an enormous flood of refugees to the United States. The best estimates are that roughly 10% of the population of the region, or two million refugees would quickly find their way to the United States.

The President's policies are designed to prevent the establishment by force of additional Marxist-Leninist regimes in Central America. We are working hard to foster free and democratic governments in the area. The vast majority of our assistance to the region is economic, not military, aid.

I hope these comments and the enclosed information will be of use to you.

SUBJECT: Outside support on Central America

We are starting to get major support from outside groups for the President's policy on Central America. Much of this is due to our Central America Outreach Working Group.

Enclosed is a listing of activity from many of these groups. Also enclosed are some samples of their products. LISTING OF ACTIVITY SUPPORTIVE OF THE PRESIDENT'S CENTRAL AMERICAN POLICY ON THE PART OF OUTSIDE GROUPS

ACCURACY IN MEDIA -- Reed Irvine, President

Accuracy in Media publishes the weekly newspaper The Washington Inquirer, which regularly contains supportive articles. They publish the "AIM Report", a newsletter which has contained articles supporting the President's policy. AIM also puts out a daily radio program called "Media Monitor" and a syndicated column, both of which regularly contain supportive opinions.

AMERICAN LEGION

The May issue of The American Legion Magazine contained an editorial written by National Commander Al Keller that urged support of the President. The March-April 1983 edition of their National Security-Foreign Relations Bulletin contained a supportive article on El Salvador. They are mailing a letter urging legislative support to over 700 leaders in the American Legion. They have invited Ambassador Stone to speak to them at their August 20, 1983 National Convention.

AMERICAN LEGISLATIVE EXCHANGE COUNCIL

This organization works with state legislatures and is coordinating a program to send a high administration official to some of the border states to speak with legislators in those states. They are working with Dolf Droge of the Office of Public Liaison to schedule a speaker on Central America for their national convention in September. They are also involved in the July Captive Nations Vigil.

AMERICAN SECURITY COUNCIL

The American Security Council has produced a film called "Attack on the Americas". They have sponsored the showing of this film on television. They work on a daily basis with Congressmen. The organization runs the Coalition for Peace through Strength, which is a bipartisan alliance of organizations and pro-defense leaders.

ANTI-DEFAMATION LEAGUE

The Anti-Defamation League has issued statements critical of the Sandinista government for their anti-Semitism and their relationship with the PLO. These statements were released to the general press, and received much circulation.

ASSOCIATION OF AMERICAN CHAMBERS OF COMMERCE IN LATIN AMERICA

This organization associates with chambers of commerce in almost every Central American country. They keep the chambers appraised of policy concerning Central America. In addition to this, members of this organization have testified before congressional subcommittees.

CENTER FOR INTERNATIONAL RELATIONS -- Lee Edwards, President

The Center for International Relations is in the process of putting together a conference on Latin America that will include representatives from public policy institutions all over Latin America and Europe. They plan to use some of the information gathered through the Outreach Group in this conference.

CENTRAL AMERICAN FREEDOM ALLIANCE -- Bob Baldwin, President

The Central American Freedom Alliance has set up a multi-faceted media committee that has to date produced many op-ed pieces for Congressmen to sign. They have been arranging for Congressmen who have been to El Salvador to be scheduled on talk shows. They are currently preparing a conference that will take place on July 19, 1983, the anniversary of the Sandinista takeover of Nicaragua. The conference will deal with the betrayal of the Nicaraguan people by the Sandinistas, and will be designed for maximum appeal to the mass media. The Alliance has also produced a twominute television spot that is now being aired. They are coordinating activities within a coalition of groups that are concerned with the Central America policy. They are also lobbying on the Boland-Zablocki amendment and Radio Marti.

COALITIONS FOR AMERICA -- Paul Weyrich, President

Coalitions for America has been responsible for the publication of many op-ed pieces written by CFA and signed by members of Congress. They have been organizing on the grassroots level.

COLLEGE REPUBLICAN NATIONAL COMMITTEE

The College Republican National Committee has produced and distributed a bumper sticker that reads:

"Support Nicaraguan Freedom Fighters". They are responsible for two posters that are being distributed on many campuses in the nation. They have put together 300 El Salvador information packets for campus activists. They are currently in the process of putting together a brochure on CISPES(The Committee in Solidarity with the People of El Salvador), a pro-left group. They have held demonstrations in front of the El Salvadoran embassy in support of the government.

CONSERVATIVE CAUCUS

The Conservative Caucus has been phone-banking the members of the organization and urging them to action in support of the President's policy. It has also been distributing information through its legislative alert network.

COUNCIL FOR INTER-AMERICAN SECURITY -- Lynn Bouchey, President

Bouchey and his organization have been especially energetic in the effort on Central America. They have made good use of information obtained in the Outreach Group. They recently began broadcasting television and radio spots on Central America in three cities (San Diego, California; Charlotte, N.C.; Grand Rapids, Michigan). They are preparing a multi-media campaign on Central America. Two direct-mail packages have been mailed. They are producing a new television documentary on Central America that will air in September. They are buying air time to show "Attack on the Americas". Bouchey has taken the lead in organizing the day-long conference "Nicaragua: The Revolution Betrayed" on July 19. They are in the process of raising money to finance a new study on El Salvador.

CUBAN AMERICAN NATIONAL FOUNDATION

The Cuban American National Foundation is an independant, non-profit institution that supports the concept of an independant and democratic Cuba. They have published a number of pamphlets critical of Castro and supportive of American policy. Their major work in support of the President, however, is on the Radio Marti effort. They have published an informational pamphlet called "U.S. Radio Broadcasting to Cuba--Policy Implications" They have been and are working on letters to Congressmen and on sending out information on Marti. They are printing a Radio Marti mailout. They are also producing letters supportive of the President's policy on Central America, and other related matters.

EAGLE FORUM -- Phyllis Schlafly, President

Mrs. Schlafly is in the process of writing an article on Central America that will appear as either a press release or as a newsletter.

FLORIDA CONSERVATIVE UNION

The Florida Conservative Union has begun a "Campaign to Protect the Americas", which will be their vehicle of support in the future. One of the more impressive single supportive pieces came from the FCU. The piece is a full-page newspaper ad that will be run in newspapers in the border states. This ad is headlined "18 Million Refugees Flee Into U.S. As Mexican Government Collapses; Reagan Declares Total Martial Law", and reads like a newspaper that would appear on the day that this would happen. The ad closes by encouraging readers to contact their Congressmen and send the message: "Don't let El Salvador fall to Communism! Please support full economic, diplomatic, and military-training assistance to the Salvadoran people." The FCU will be running this ad mainly in the districts of Congressmen who are not supportive of the President's policy.

THE FORUM

The Forum is a group of women that all work in occupations that deal in some way with foreign policy. They are a non-profit, non-partisan discussion group. They have hosted Geraldine Macias, a former nun who talked about why she and her husband, a former official in the Sandinista regime, left Nicaragua. They have also had at their meetings guests including administration officials, House and Senate staff members, and other knowledgable persons. They will be focusing in the next

few meetings on Central American issues, and they hope to feature such speakers as Mr. Adolfo Calero, the leader of the FDN in Nicaragua.

FREE THE EAGLE

Free The Eagle is a citizen's lobby group. They have published articles in their monthly "State of the Nation" newsletter that have been supportive of the President's policy.

HERITAGE FOUNDATION

The Heritage Foundation has published a number of "backgrounders" concerning the President's policy. They have written op-ed pieces in support of the policy and have had pieces published in the Washington Times and the Baltimore Sun, among other periodicals and newspapers. Richard Araujo, the Latin American Policy Analyst for the Foundation, has testified in support of the President's policy on five different occasions before Congressional committees. He has participated in debates on such television shows as The Today Show and the McNeil-Lehrer Report, as well as in a debate with Congressman Dodd on the Cable News Network.

INSTITUTE OF RELIGION AND DEMOCRACY

The Institute of Religion and Democracy has encouraged continued United States assistance to El Salvador. They recently published a booklet entitled "The Catholic Church in El Salvador".

JEWISH INSTITUTE FOR NATIONAL SECURITY AFFAIRS

The Jewish Institute for National Security Affairs published a large piece entitled "The PLO in Central America", as well as supportive editorials, in the JINSA Newsletter (Vol. III, No. 21). This newsletter reaches 8300 leaders in the Jewish and defense communities. They plan to publish other supportive material in future newsletters. JINSA plans a major panel discussion in September on Central America. They also are sending speakers to organizations in the Washington D.C. area, and they are organizing public meetings for leaders in the Jewish community.

MARANATHA CAMPUS MINISTRIES

Maranatha Ministries is writing op-ed pieces and will devote the August issue of their publication The Fore-runner to Central America. (The publication reaches 50,000-100,000 people).

MORAL MAJORITY -- Jerry Falwell, President

The Moral Majority has published supportive articles in their newsletter The Moral Majority Report. They are working on an effort to get relief to orphans in El Salvador.

NATIONAL CONSERVATIVE POLITICAL ACTION COMMITTEE

After the President's televised address, NCPAC sent letters to every Congressman urging their support for the President's policy. They are planning a mailing that will be focusing on Congressmen who oppose the President's policy.

NATIONAL FORUM FOUNDATION

The National Forum Foundation is preparing issue papers to distribute to members. They will also participate in the July 2 Captive Nations Vigil. They were instrumental in setting up early planning sessions shortly after the President's address.

NEW WORLD DYNAMICS

New World Dynamics is a non-profit organization to encourage greater public participation in foreign policy issues. Col. Samuel T. Dickens, Director of New World Dynamics, has debated guerilla leaders on the Cable News Network, on various local channels, and on the radio talk show "Evans and Novak". He has also held press conferences in Honduras, El Salvador, and Guatemala, speaking in Spanish at these press conferences. They have issued a bulletin called Foresight that contains supportive material.

U.S. DEFENSE COMMITTEE

They are producing a mailing that should reach 47,000 people. The lead story in the May/June 1983 edition of

their bi-monthly newsletter <u>Defense Watch</u> is headlined "Congress Warned to Act on Fl Salvador, Before It's Too Late". They are sponsoring trips to El Salvador for three supportive Congressmen. They also plan a mailing targeted toward unsupportive Congressmen.

VIGUERIE COMPANY

The Richard A. Viguerie Company is hosting a weekly breakfast that is attended by leaders on the Central America support effort. The monthly Conservative Digest will devote its full issue in July to Central America. They are producing a thirty-minute television show and some ad spots. They have mailed to 5-10 million people urging post cards in support of Central America and the President's policy.

WOMEN'S ALERT

Women's Alert has set up seminars all over the country. They plan a regular letter to edify women on El Salvador and to bring them to stand with the President.

ADDITIONAL SUPPORT FOR THE PRESIDENT'S POLICY

NATIONAL CENTER FOR PUBLIC POLICY RESEARCH

This organization has been devoting its full energy to the July 1-2 "Captive Nations Vigil", which will take place at the Vietnam Memorial.

NATIONAL CHRISTIAN ACTION COALITION

The actions of the National Christian Action Coalition have been concentrated in the areas of informing and indirect lobbying. They have included in their bulletins supportive stories on Central America. These bulletins reach over 16,000 churches nationwide. They also include information on Central America in their Leadership Training seminars. They have encouraged members to lobby their Congressmen. Also, they have sent facts obtained through the Office of Public Liaison to their most active members and encouraged them to write letters to the editors of their local newspapers that include these facts.

NAVY LEAGUE

The Navy League recently adopted a resolution of support at their national convention.

RESERVE OFFICERS ASSOCIATION

The Reserve Officers Association passed a national resolution of endorsement on the Carribean Basin initiative. They published a supportive editorial in the June issue of their magazine, The Officer. At their recent national convention in Salt Lake City, they urged state and local chapters to contact their congressmen to urge support.

* Jorge Mandi: Sandinista spokesman, told a reporter for the Kuwaiti newspaper Al Watan, 6/7/79
"There is a long standing blood unity between us and the Plaestinian revolution. Many of the units belonging to the Sandinista movement were at Palestinian revolutionary bases in Jordan. In the early 1970s, Nicaraguan & Palestinian blood was spilled together in Amman and in other places during the Black September battles.

A number of Sandinistas took part in the operation to divert 4 aircraft which the PFLP seized and landed at a desert airfield in Jordan. One of our comrades was also wounded in another hijack operation in whichLeila Khaled was involved. She was in command of the operation and our comrades helped her carry it out. It is natural, he explains to us, therefore, that in our war against Somoza, we received Palestinian aid for our revolution in various forms.

* This aid/solidarity was formalized in two publicly proclaimed joint communiques issued in 1978.

- 1st Signed in Mexico City on 2/5/78 which affirmed the "ties of solidarity existing between the two revolutionary organizations" and attached "the racist state of Israel"

WASHINGTON, DC, June 7...The Anti-Defamation League of B'nai B'rith yesterday called on Sandinist authorities to return the nation's only synagogue to the Nicaraguan Jewish community. The synagogue was confiscated after the Sandinist's came to power in 1979.

In a meeting with the Nicaraguan Ambassador to the United States,
Antonio Jarquin, the League's Associate National Director, Abraham H.

Foxman, also urged the Nicaraguan government to publicly denounce antiSemitism in order to make Jews feel "welcome once more in their homeland."

Speaking at a news conference here, Mr. Foxman said the meeting was held at the initiative of Ambassador Jarquin. ADL had issued a report May 23 that the country's Jewish community had been forced into exile and that Jewish-owned property had been confiscated, in addition to the synagogue in Managua.

The Ambassador promised at the meeting yesterday, according to Mr. Foxman, to investigate the situation in Nicaragua, particularly the confiscation of the synagogue as well as three other cases involving the seizure of private Jewish-owned property. These cases had been submitted to Nicaraguan authorities for consideration more than a year ago, he added.

Ambassador Jarquin, the ADL official went on, acknowledged that the Nicaraguan government had not responded to these ADL inquiries nor to a request that the authorities set forth the conditions under which Nicaraguan Jews could return to their country.

Mr. Foxman was accompanied to the meeting by I. Barry Mehler, Chairman of the League's Latin American Affairs Committee, Jess Hordes,
Associate Director of ADL's Washington Office, and Rabbi Morton M.
Rosenthal, Director of the League's Latin American Affairs Department.

Mr. Foxman emphasized that ADL's representations to the Nicaraguan government were being made on behalf of the entire Jewish community of Nicaragua. He said that the League sought the opportunity for each member of the community to obtain the principle of due process of law.

The Ambassador was assured, Mr. Foxman said, that ADL's actions in behalf of Nicaraguan Jewry at this time "have absolutely no connection with the present political situation involving the United States and Nicaragua."
