#### I. 1983 Supp/84 - Authorizations Bills

Reported out of Committee (S.1347 and HR.2992). Awaiting floor action expected after July 10 (after July 4 break) and before Aug. 5 or 6 (the summer recess).

Note: The 1983 Supp. was included by both the SFRC and HFAC with the regular 1984 Bill. Furthermore, the House Bill is for '84 and '85. The Senate Bill is only for '84.

SFRC bill provides \$76.3 million (FMS, MAP, IMET) for El Salvador and, of this, \$16.5 million is from supplemental request.

HFAC bill provides \$65 million for El Salvador. \$8.7 is from the supplemental request.

#### II. 1984 Appropriations Bills

Process has not started. Foreign Ops. Subcommittees have not marked up. Doc Long Subcommittee postponed 6/16 mark-up to a date uncertain. Kasten Subcommittee has not yet scheduled a mark-up date.

#### III. 1983 - Supplemental Appropriations Bill

Passed by the full House and the Senate. Conference likely sometime after the July 4 recess.

Note: Senate Bill will have \$50 million for El Salvador, the House Bill nothing.

#### IV CBI

House Ways and Means marked-up June 21 and will go the the House Floor after the July 4 recess. The CBI was passed by the Senate as an amendment to the bank withholding tax repealer. The House and Senate must put the two vehicles together, assuming the full House passes the Bill.

There is little wrong with the Executive Order. It is a good idea to preempt Congressional action on the Jackson-Mathias proposal. There is, of course, no possibility of a national consensus on U.S. policy for the region. Too many organized elements want a Marxist victory there.

The predicted appointment of Henry Kissinger as chairman, however, would be a <u>disaster</u> for our efforts to generate grassroots support for the President's policy in Central America.

This morning, one conservative leader very supportive until now of the President's Central American policy said he had no intention of working for a policy crafted by Kissinger. Paul Weyrich described Kissinger as "a mortician of U.S. national interests. He applies cosmetics and then buries them."

A Kissinger appointment would tend to dry up contributors to favorable grassroots lobbying appeals. It was the conservative grassroots, after all, who roared their approval when candidate Reagan in 1976 promised a new Secretary of State. A Kissinger appointment would display a lack of understanding of the nature of the President's constituency. We would lose a lot of badly needed support.

<u>SUMMARY</u>. This memorandum forwards for your consideration a proposed Executive order which would establish the National Bipartisan Commission on Central America.

BACKGROUND. The proposed order would establish a Commission, to be composed of not more than 11 members to be appointed or designated by the President, from among distinguished leaders of government, business, labor, education, and the Hispanic and religious communities. The President will designate a Chairman from among the members of the Commission.

The Commission will study the nature of United States interests in Central America and the threats now posed to those interests and report to the President, the Secretary of State and the Congress on elements of a long-term United States policy that will best respond to the social, economic, and democratic development in the region, and to internal and external threats to its stability and security. The Commission also will provide advice on means of building a national consensus on a comprehensive United States policy for the region.

The Commission will report to the President by December 1, 1983. Unless sooner extended, the Commission will expire 60 days after submitting its final report.

None of the affected agencies has objected to the proposed Order.

RECOMMENDATION. I recommend that you sign the proposed Order.

#### FACT SHEET

The President today signed an Executive Order which created the National Bipartisan Commission on Central America. The Commission will be composed of not more than 11 members, to be appointed or designated by the President, from among distinguished leaders of the government, business, labor, education, Hispanic and religious communities. No more than six members will be of the same political party. The President will designate one of the members to serve as Chairman of the Commission.

The Commission will study the nature of United States interests in Central America and the threats now posed to those interests and provide advice to the President, the Secretary of State and the Congress on elements of a long-term United States policy that will best respond to the challenges of social, economic, and democratic development in the region, and to internal and external threats to its stability and security. The Commission also will provide advice on means of building a national consensus on a comprehensive United States policy for the region.

#### NATIONAL BIPARTISAN COMMISSION ON CENTRAL AMERICA

By the authority vested in me as President by the Constitution and laws of the United States of America, and in order to establish, in accordance with the provisions of the Federal Advisory Committee Act, as amended (5 U.S.C. App. I), the National Bipartisan Commission on Central America, it is hereby ordered as follows:

Section 1. Establishment. (a) There is established the National Bipartisan Commission on Central America. The Commission shall be composed of not more than 11 members spointed or designated by the President. These members shall be drawn from among distinguished leaders of the government, business, labor, education, Hispanic and religious communities. No more than six members shall be of the same political party.

- (b) The President shall designate a Chairman from among the members of the Commission.
- Sec. 2. Functions. (a) The Commission shall study the nature of United States interests in the Central American region and the threats now posed to those interests. Based on its findings, the Commission shall provide advice to the President, the Secretary of State and the Congress on elements of a long-term United States policy that will best respond to the challenges of social, economic, and democratic development in the region, and to internal and external threats to its security and stability. The Commission also shall provide advice on means of building a national consensus on a comprehensive United States policy for the region.

- (b) The Commission shall report to the President by December 1, 1983.
- Sec. 3. Administration. (a) The heads of Executive agencies shall, to the extent permitted by law, provide the Commission such information as it may require for purposes of carrying out its functions.
- (b) Members of the Commission shall serve without compensation for their work on the Commission. However, members appointed from among private citizens of the United States may, subject to the availability of funds, be allowed travel expenses, including per diem in lieu of subsistence, as authorized by law for persons serving intermittently in the government service (5 U.S.C. 5701-5707).
- (c) The Secretary of State shall, to the extent permitted by law, provide the Commission with such administrative services, funds, facilities, staff and other support services as may be necessary for the performance of its functions.
- Sec. 4. <u>General</u>. (a) Notwithstanding any other Executive Order, the functions of the President under the Federal Advisory Committee Act, as amended, which are applicable to the Commission, shall be performed by the Secretary of State, in accordance with guidelines and procedures established by the Administrator of General Services.
- (b) The Commission shall, unless otherwise extended, terminate 60 days after submitting its final report.



#### Central America



- Welcome to the White House.
- o The President, Judge Clark and I are delighted you could be here today.
- o You are here today because of our concern regarding Central America.
- o The President believes -- indeed the entire Administration believes -- that we cannot afford to lose in Central America.
- o But we are losing as of today and not only in El Salvador.
- o We cannot afford to lose because it is to close and it is too important.
  - -- San Salvador is closer to Washington, D.C. than Washington, D.C. is to Los Angeles.
  - -- Central America is the bridge between the

    Americas -- north and south. It is not isolated,

    but linked by land, air, and sea routes to North

    and South America and the Caribbean.

- -- Two-thirds of our trade go through Panama Canal and the Caribbean.
- -- In war time or any emergency short of war, much of our men and materiel would go through those sea lanes to Europe or the Middle East.
- -- Forty percent of our imported oil goes by the island of Grenada in the East Caribbean -- an island rapidly becoming a Soviet/Cuban political and military base.

- o If Central America and nearby states were to become communist dictatorships we would face on unprecedented and illegal wave of immigrants fleeing those dictatorships.
  - -- People have always fled communist revolutions by the millions: there are no exceptions.



Requires the President to make certain determinations as part of his certification on progress in El Salvador in the human rights and political areas.

#### Discussion

Section 728 of the International Security and Development Cooperation Act of 1981 (P.L. 97-113) requires the suspension of all military assistance and sales to El Salvador and the prompt withdrawal from El Salvador of members of the Armed Forces performing defense services and related activities unless the President certifies to the Speaker of the House and the Chairman of the Senate Foreign Relations Committee that the Government of El Salvador:

- (a) is making a concerted effort to comply with internationally recognized human rights;
- (b) is achieving substantial control over all elements of its own armed forces to bring an end to their indiscriminate torture and murder of Salvadoran citizens;
- (c) is making progress in implementing economic and political reforms; and
- (d) is committed to the holding of free elections.

Such certification, made thirty days after enactment of P.L. 97-113 and required every one hundred and eighty days thereafter, is currently due to the Congress on July 29, 1983. H.R. 1271 would amend P.L. 97-113 by requiring the President to determine that, in addition to certifying items (a) through (d) noted above for the fourth certification, the Government of El Salvador has made good faith efforts both to investigate the murders of the seven United States citizens in El Salvador in December 1980 and January 1981 and to bring to justice all those responsible for those murders, and has taken all reasonable steps to investigate the killing of Michael Kline in El Salvador in October 1982. Similar certifications regarding the murders of United States citizens have already been made twice as required under section 728.

Such certification and determination requirements are generally viewed by the Administration as counterproductive, particularly in this case where the Administration is already taking the initiative required by H.R. 1271. Although the enrolled bill further impinges on the President's ability to conduct foreign policy, the Administration has previously indicated no objection to its enactment, given the Administration's commitment to the complete investigation into the murders in question.

The enrolled bill passed the House and Senate by voice vote.
