SUBJECT: President's Speech on Iceland, 2:15 p.m. TODAY

Tony, in the opening paragraph of this afternoon's speech on Iceland, the President makes reference to the audience, referring to it only as the "Executive Exchange Commission." In fact, 2/3 of the audience will be made up of pro-defense, pro-democracy, religious, human rights and ethnic group representatives.

Thus, I recommend that the following be added to the end of the first paragraph (David Chew approves the concept):

Of course, I would also like to welcome our other guests who have worked so closely with this Administration to promote peace, human rights and freedom around the world.
