SUBJECT: Calligraphers

As you know, the Executive Residence Staff includes five (5) persons (Bill Gemmell, John Scarfone, Rick Muffler, Judy Spangler and Shirley Campolieto) that work in East Wing Offices under the title of the Calligraphy Office. Shirley Campolieto holds the position of a calligrapher but in fact works directly for the Social Office on a full time basis.

During the first months of the Carter Administration, the calligraphy office was reduced from a staff of seven to three. After just a few months of working at that staffing level, the Social Secretary made it known that this was an unacceptable level for the amount of work that needed to be accomplished. Part-time help was hired to cover the workload. Not until the beginning of this Administration were we able to acquire the necessary authorization from the Congress to hire and fund two full-time people to assist with the calligraphy duties. One of those two positions is now part of the Social Office operation; specifically, Shirley Campolieto who handles the lists of guests for the social events.

In the meantime, the demands on the Calligraphy Office have continued to grow to the point that there is now another full-time equivalent part-time person working in the Calligraphy Office, Estelle Stoltz. Estelle started as a volunteer over five (5) years ago and now is a paid employee funded by the Office of Administration as a full-time temporary. Estelle is highly thought of by the Calligraphy Chief Bill Gemmell and has been praised for the professional work that she does. Estelle has never complained about her status but has felt left out in that she has not received any benefits normally associated with government employment due to her status as a temporary employee.

In trying to position the staff for the remaining Reagan years and the changes that will occur in eighteen (18) months, I would propose that Shirley Campolieto be removed from the Executive Residence Staff and be picked up by the Executive Office of the President. Further, Estelle Stoltz would then be taken from the temporary status and be hired by me as a member of the Calligraphy Office and the Executive Residence Staff. Another reason for doing this is the annual budget process question which is asked of us by the Congressional Committees concerning the involvement of the Executive Residence budget with support of the East and West Wings. We have always been able to say that the funds appropriated to the President for the operation and maintenance of the Executive Residence are expended solely for that purpose. The Executive Residence budget is a separate entity from the Executive Office of the President and Office of Administration budgets. The fact that Shirley works solely for the Social Office removes her from the activities of the Executive Residence as indicated in our appropriation language.

Estelle deserves this consideration for the fine service that she has given the Administration and the Executive Residence can more appropriately lay out our staffing for the coming years. Your assistance in this matter will be greatly appreciated.

I have not discussed this proposal with anyone other than Bill Gemmell, Chief Calligrapher.
