



Dear Ed:


Your candid and informative remarks at the Carlton Club luncheon the other day were extremely well received by those corporate representatives who attended. I was especially interested in your comments relating to corporate support for the Ambassadors Ball, during which you expressed the need for the private sector to pick up the slack occasioned by necessary reductions in Federal spending.

My law firm has, over the past several years, represented many of the larger voluntary health organizations such as the National Multiple Sclerosis Society and the Arthritis Foundation. These organizations have traditionally opposed the diminution of government financial support for biomedical research and rehabilitation programs. This is due in large part to their increasing inability to expand innovatively upon their private philanthropic techniques.

I believe that it would be extremely valuable for the Administration to begin a dialogue, at the White House level, with these organizations. The message that President Reagan is willing to explore ways in which the Administration can encourage increased private sector support for charities would be well received if properly planned and orchestrated. It could conceivably gain support for federal program reductions from some of your most vocal opponents in this area.

If you feel that it would be helpful to pursue this idea further, I would be most happy to meet with you or whomever you feel appropriate to assist.

July 9 - July 28, 1981

Outstanding high school students are invited to spend three weeks this summer studying politics and government in Washington, D.C. They will question major national leaders and debate current issues as they participate in a demanding academic introduction to American national government.

The Washington, D.C. session of the 41st Annual Junior Statesmen Summer School will be held at Catholic University from July 9 through July 28, 1981.

The curriculum offers a systematic introduction to American government. An extensive speakers program will be closely integrated with classroom instruction. Summer School students will meet and question many national leaders, including members of the House and Senate, key members of the Reagan administration, lobbyists, and journalists. A Congressional Workshop will provide a forum for student debates on contemporary political issues.

In addition to an extensive speakers program, each student will have the opportunity to observe the House and Senate in session, to attend Committee hearings and to take advantage of the unique educational resources that only Washington, D.C. offers. Each student writes a research paper which will involve personal interviews, monitoring public hearings, and library research.

An outstanding faculty, drawn from some of the best universities in the nation, will work with the students individually and in small groups. The collegiate academic environment stresses individual student projects involving substantial reading, research, and writing.

High school students applying for admission should have a superior academic record, possess leadership qualities and have at least two semesters of high school remaining.

Junior Statesmen Summer School graduates generally receive five units of high school credit for the American Government course. Following the session, transcripts including course descriptions will be sent to high school principals and to the graduates. High school credit, if desired, should be arranged in advanced with your school.

Students live in a modern, air-conditioned dormitory at Catholic University. The campus is situated in a pleasant residential neighborhood. The Capitol is a few minutes from the campus via the Metro — Washington's new rapid transit system.

The faculty and teaching assistants live in the dormitory with the Summer School students and are responsible for their health, safety and supervision.

The program is intensely academic, but there are many opportunities for social and recreational activities. Summer School students will be able to visit the Smithsonian Institution and the many other museums, art galleries, and landmarks for which Washington is so famous.

Perhaps the most rewarding part of The Junior Statesmen Summer School experience is the opportunity to make life-long friends. Students from diverse backgrounds form a close, supportive community. The Summer School experience is often cited as the most valuable educational experience of a young person's life.

TUITION, TRANSPORTATION, ROOM AND BOARD

The total cost of the three-week session of the Washington, D.C. Summer School is \$1320 from San Francisco, Los Angeles or Seattle. This covers:

— **TUITION AND TEXTBOOKS**

— **ROUNDRIP PLANE TRANSPORTATION FROM SEATTLE, SAN FRANCISCO, OR LOS ANGELES.** We have a limited number of plane seats reserved from each city. Transportation can be arranged from other cities at a higher cost. Summer School students will travel together as a group on United Airlines. Students will depart Thursday morning, July 9 and return late Tuesday evening, July 28.

— **ROOM AND BOARD** at Catholic University including three meals per day with unlimited seconds. Lunches will also be provided on days when Summer School students are off campus meeting speakers in the Capitol and various Executive departments. Students are housed two to a room in a modern, air-conditioned dormitory with semi-private bathrooms.

This fee, payable after your acceptance, covers everything except miscellaneous personal items.

Many service clubs, community organizations, local governments, and school sources are able to provide scholarship funds to students. Often school administrators, faculty members, and The Junior Statesmen Foundation are able to help arrange these scholarships or direct students to potential fund raising sources within their community. AMERICAN GOVERNMENT The Program of Study

ACADEMIC COURSEWORK

The American Government course is equivalent to a one semester college class. Through lectures, college-level textbooks, and small group discussions, this course offers a systematic examination of the institutions and processes of American government. Topics covered in detail include American political philosophy, the Congress, the Judiciary, the Presidency, the bureaucracy, parties and pressure groups, and the media. Case studies of major domestic and foreign policy issues will be used to illustrate the dynamics of the American political system.

In advance of the Summer School session, students will be sent a reading list and asked to do some reading prior to their arrival in Washington. Classes will be held six days a week.

An extensive speakers program, a research project, and student debates on national issues are carefully integrated into the American Government course.

A typical day will include a speakers program in the Capitol, as well as classes at the University.

SPEAKERS PROGRAM

Junior Statesmen Summer School students will meet and question major national leaders. Informal, off-the-record sessions with headline figures in the news will be held in the Capitol and in government agencies throughout Washington. Senators, Members of the House of Representatives, key members of the Reagan administration, lobbyists, campaign managers and journalists will give Summer School students a behind-the-scenes look at the real world of politics.

Speakers at past Junior Statesmen sessions have included Ronald Reagan, Earl Warren, Warren Magnuson, Gerald Ford, Dwight Eisenhower, Cesar Chavez, Richard Nixon, Jerry Brown, Ed Clark, Alan Cranston, Ed Meese, John Tunney, Howard Jarvis, Ramsey Clark, Casper Weinberger, and John Anderson.

RESEARCH PAPER

Each student will write an analytic research paper which focuses on the process of policy formation. For example, students might research the legislative history of a bill, analyze a Supreme Court ruling, or study an administrative decision. In preparing their research paper, students may interview government officials, lobbyists and journalists, attend Congressional hearings, and undertake library research. They will be able to take advantage of the unique resources that only Washington offers.

CONGRESSIONAL WORKSHOP

Summer School students create and operate a debating forum patterned after Congress. Students are required to write a legislative resolution on a current issue and advocate their position before a session of the Congressional Workshop. Daily sessions of the Congressional Workshop are held during Summer School, with some of the debate sessions taking place in Committee Rooms in the Capitol. Through the Congressional Workshop, Summer School students gain an understanding of parliamentary procedure, current political issues, persuasion, political theory, and library research.

HOW TO APPLY

Applicants for admission should submit:

- (1) Application for Admission printed in this brochure.
- (2) An autobiographical sketch, not longer than three pages, covering your academic achievements, academic and vocational aspirations, involvement in school and community activities, and interest or involvement in politics and government.

(3) High school transcript.

(4) Three letters of recommendation from academic teachers, your high school principal or other school administrator, counselor, or a government official or civic leader. These confidential letters of recommendation should comment on your scholastic abilities, judgment, integrity, leadership abilities, and maturity to the extent that the writers have had an opportunity to observe.

All materials should be received by Friday, May 15, 1981. Applications will be considered in the order in which they are received. For this reason, it is best to apply as early as possible.

Late applications will be considered, space permitting.

Upon acceptance, students will be sent an information packet containing detailed information including what to bring, transportation, and complete course descriptions.

Enrollment at the Summer School is limited for forty outstanding West Coast high school students.





Meese: City must learn to look to state for aid

Baltimore's renaissance will not suffer under the Reagan administration if city officials learn to work with the state government, top presidential adviser Edwin Meese said Thursday.

Meese made the comments after a speech to a convention of independent truckers at Baltimore's Convention Center.

"President Reagan has tremendous respect for what Baltimore has accomplished," said the presidential counselor.

The president's new policies, including sharply reduced federal aid and shifting responsibilities to state governments, need not cripple the

city's efforts at renewal, he said.

"There is a phasing-in period for these new changes we are making, that will give the city time to learn to deal with the state just like they did with the federal government," he said.

Meese did not meet with Mayor William Donald Schaefer or other city officials during his two-hour visit to the city. Chris Hartman, the mayor's spokesman, said the mayor did not know Meese was in town.

Schaefer, who endorsed former President Jimmy Carter for re-election last year, has been trying to get top Republican and White House officials to visit Baltimore to help make sure the city gets its share of remaining federal aid.

On other subjects, Meese said

Reagan was considering eliminating the federal 55 mph speed limit and that striking air traffic controllers would not be allowed back on the job unless they could prove they had been intimidated or harassed into joining the strike.
