
Your letter of August 22nd to President Reagan was referred to this office because it concerns a Federal tax matter.

We contacted officials of the Internal Revenue Service District Office in Columbia, South Carolina who until recently, had jurisdiction over your account. They advised us that approximately four weeks ago you requested that your account be transferred to our Los Angeles District Office. We have sent a copy of your letter to them for their information. We suggest that if you require additional assistance you should contact the nearest local office in Los Angeles.

In your letter you indicated a desire to redeem the personal property seized by the IRS. Personal property (such as motor vehicles) may only be redeemed prior to the sale. Columbia District officials informed us that they also sold real estate which belonged to you. You have the right to redeem real estate sold at an IRS sale within 180 days of the date of sale. If you wish to exercise your right of redemption we suggest you contact IRS officials in the Los Angeles District.




