Having won on the procedural issues, we now face the key substantive votes. Barring an unforeseen change in Democratic leadership tactics, we expect the key substantive votes to take place tomorrow.

The legislative strategy group recommends that you make additional phone calls to those on the attached list. All ***** those on the attached list voted <u>against</u> us on the procedural issue -- but might vote with us on the substantive vote.

Our tactical approach to particular votes tomorrow -- there will, in fact, be several votes -- is still being worked out. But under all conceivable alternatives, we will want people to "vote for the Gramm-Latta package" -- for reasons summarized on the attached sheet titled "What's At Stake."

Because the people on the attached list voted against us on procedure, you might mention with each that: you could understand how they might feel they had to vote with the leadership on procedure, but now....

<u>Please note:</u> More particularly relevant points are noted by individual Congressmen's names.

FYI: For those who voted with you on the procedural question today, we are hand-delivering a signed letter of thanks from you -- with a request that they be with you again tomorrow.

What's At Stake

- \$22.4 billion in additional real budget savings over FY 82-84. Annual amounts are \$5.9 billion ...\$8.1 billion ...\$8.4 billion in FY 82, 83, 84, respectively.
- Correction of serious shortfall on entitlement savings from the first Budget Resolution and Reconciliation Instruction. Savings shortfall is \$17 billion overall for FY 82-84, and \$26 billion for 9 specific entitlement programs addressed in Gramm-Latta amendment. On these 9 programs committees achieved only <u>34 percent</u> of instruction.
- 3. Removal of threat to FY 84 balanced budget. In many cases, the House Committee adopted temporary cuts and one year savings. As a result, the out-year savings are far below what Gramm-Latta required:

SUBJECT ' Telephone calls regarding Vote on Rule

As you know, we expect the floor vote on the reconciliation rule tomorrow mid-day (EST). Max Friedersdorf thinks we are within 12 votes of possible victory (Confidential). The Legislative Strategy Group recommends your telephoning the members noted on the attached. They are all uncertain votes at this point. *

The following is the text of a telegram we are sending this evening, on your behalf, to all those who supported Gramm-Latta I. Your telephone call would best simply reinforce this message.

TELEGRAM TO 190 REPUBLICANS AND 63 DEMOCRATS:

"URGENTLY REQUEST YOUR SUPPORT FOR RULE TO PERMIT SINGLE UP-OR-DOWN VOTE ON OUR BIPARTISAN BUDGET PACKAGE TO SAVE ADDITIONAL \$20 BILLION CONSISTENT WITH GRAMM-LATTA I. I CONSIDER THIS VOTE ON THE PREVIOUS QUESTION VITAL TO OUR ECONOMIC RECOVERY PROGRAM. GAG RULE TO DENY HOUSE CONSIDERATION OF OUR ENTIRE PACKAGE IS UNACCEPTABLE AND DENIES AMERICAN PEOPLE OPPORTUNITY TO BE HEARD ON RUNAWAY FEDERAL SPENDING. OUR PREVIOUS EFFORTS WILL BE BADLY DAMAGED UNLESS WE CAN STAY TOGETHER ON THIS ISSUE. THEREFORE, I SEEK YOUR SUPPORT TO RECONFIRM YOUR VOTE ON THE MAY 7 BUDGET RESOLUTION."

As you know, we expect the floor vote on the reconciliation rule tomorrow mid-day (EST). Max Friedersdorf thinks we are within 12 votes of possible victory (Confidential). The Legislative Strategy Group recommends your telephoning the members noted on the attached. They are all uncertain votes at this point. *

The following is the text of a telegram we are sending this evening, on your behalf, to all those who supported Gramm-Latta I. Your telephone call would best simply reinforce this message.



Walter Jones represents the 1st Congressional District of North Carolina (northern coastal part of the state). Now serving in his 9th term, Walter is a member of the Agriculture Committee and is Chairman of the Merchant Marine and Fisheries Committee. Walter is a member of the Conservative Democratic Forum, and he has met with the President in a group setting on a number of occasions.

Philosophically, Walter has been considered one of the more conservative Members of Congress on defense and economic issues. This year, however, he has not supported the Administration's position on any of the key votes pertaining to the Budget and Reconciliation bills. Based upon conversations with White House staff, Walter likes many features of the Conable-Hance proposal. However, as a Committee Chairman whose name was put in nomination for that position by Speaker O'Neill, Walter feels intense pressure to support the Democratic Leadership of the House on key issues.

At this point, Walter is reported to be uncommitted on the tax bill but likely to be leaning against the Administration's position. He has agreed not to announce his final position on the tax bill until he has spoken again with an Administration official; and, irrespective of how he plans to vote, he has agreed not to attempt to influence the votes of other Members of the North Carolina Delegation.

AT 1987 NA 311133 It is felt that Walter's historical voting record in the House and his perceived influence with other North Carolina Democrats justifies direct Presidential contact.

Walter has had a number of health problems requiring hospitalization this year. Most recently, he was operated on to replace a vein along the entire length of one leg. It is anticipated that he will enter the hospital again in the near future for surgery necessitated by a gall bladder operation earlier in the year.

Inquire about Walter's health, noting his recent vein replacement surgery; and express the hope that he will be fully recuperated soon.

Acknowledge your awareness that Walter has been under intense pressure to support the Rostenkowski-O'Neill tax plan. State your conviction that the Conable-Hance bipartisan bill is best for the nation and has the support of the American people.

Stress that the Conable-Hance bipartisan proposal is a <u>permanent</u> tax cut. The Rostenkowski-O'Neill plan is another make-believe tax cut that dissolves into a huge tax <u>increase</u> after two years-a continuation of the policies of the past which promised working people tax relief they never saw.

Characterize the third year "trigger" in the Rostenkowski-O'Neill plan as a gimmick that will not work by its own design. Point out that the "trigger" is based on meeting the Administration's economic goals for the Federal deficit, interest rates and inflation, but abandons the tax policies on which these goals are premised. Note, for example, that the Rostenkowski-O'Neill plan will increase the deficit \$7.3 billion more in 1983 than the bipartisan proposal; and this by itself defeats the "trigger".

Point out that the Conable-Hance proposal is also targeted to help small businesses (e.g., those which pay business tax at personal rates, etc.), and will provide special help to farmers (e.g., the gift and estate tax provisions).

Acknowledge that Walter has been unable to support the bipartisan coalition in the House on the key Budget and Reconciliation votes. Express the hope that he can join in support of the Conable-Hance bipartisan tax bill, which is vitally important to the nation's economic recovery.

- Point out that the fundamental difference between the two tax proposals is that the bipartisan plan offers real tax reduction, while the Ways and Means plan allows taxes to continue to increase on the working people of this country.
- Stress that the Conable-Hance bipartisan proposal is a <u>permanent</u> tax reduction -- a three-year tax cut to be followed by indexing.

- -- Characterize the Rostenkowski-O'Neill proposal as no tax cut at all, unless you assume you're only going to live two years. Reiterate your strong conviction that the bipartisan plan of permanent tax relief is best for the nation and the American people are behind it.
- Acknowledge awareness of Democratic Leadership efforts to pressure House Democrats into supporting their tax proposal; and thank Glenn for standing by his convictions on what is in the best interest of the people.
- -- Express that, with the support of Glenn and other Members on both sides of the Aisle, you are confident of another important victory for the American people when the tax legislation is considered on the House Floor.
- -- Note that it obviously is impossible to completely solve the tax mess in a single piece of legislation; and indicate that part of the solution over time will be to protect against the enactment of unwise measures.
