Dear Mr. Deaver:

Today as I was driving home in my car, I heard on the radio that President Reagan had announced that there would be absolutely no change in the security arrangements surrounding him, and that he intends to allow his security forces to continue exactly as they have in the past. Night before last, I read a resume of exactly what happened before and during the assassination attempt, and afterwards determined to write to you because it appears to me that you have the President's interests at heart. I first thought that Ed Meese would have them also, however, I am not at all certain that any of the men surrounding the President actually deserve his trust. I am informed, however, that you share the President's views and very probably would try to get a message to him.

Before I continue to express my views concerning the foregoing, I do wish to state that the Republican Committee may as well quit sending me letters asking for donations to support Republicans when I do not know whether or not they are conservatives. I am willing to support conservative Republicans, but I am no longer inclined to support just any Republican indiscriminately, and in preference to supporting a liberal Republican, would support a Democrat if he were conservative.

I wish to advise that I have President Reagan's interest at heart when I state my opinions on these matters. I was a Presidential elector from Kansas for him, unanimously chosen from the Fourth District, and really spent more money than I should have to help secure his election when I found out that the team he had working for him in Kansas was not at all in sympathy with him and were letting him down.

I merely mention these things because of what I wish to say hereafter. It seems to me there never has been a President more prone to assassination than is President Reagan. I fought for him because I sincerely believe that he is sincere in his efforts to create a new direction in American policy. However, there have been several things which disturb me, the principal one being the fact that the assassination Mr. Michael Deaver April 23, 1981 Page 2

attempt took place the day after the Trilateralist party met in Washington. It is quite true that Vice-President Bush carried on very well in the absence of the President, but who stands to gain more from his death than does Bush? I am informed, reliably, that the Bush family and the father and mother and uncle of the young man who attempted to assassinate him are close friends, and that they have donated large sums to his campaign. While it is true that Rockefeller indicated that Bush was no longer a trilateralist, I think this was simply a cover-up which the trilateralists are thoroughly capable of doing. I am also concerned that for some reason, President Reagan has surrounded himself by well known trilateralists. Weinberger has, in effect, associated himself with a man notoriously pro-Castro, and from what I read in the magazines, he is not doing too outstanding a job as Secretary of Defense. This could well be understood, since he apparently has never surrendered his trilateralist convictions.

More to the point is my opinion that William Webster, Chief of the FBI, was grossly negligent in carrying out his duties. He has established an entirely new guideline and was a Carter appointee and a follower of Carter, toadying to the trilateralist and CFR movement headed by David Rockefeller, and is a known associate of Marxist organizations. It is indeed strange that this man who attempted to assassinate the President had been arrested for following him during the campaign, and when boarding an airplane was caught with not one, but three pistols, and fifty rounds of ammunition. Yet the FBI carried no list of his name, per Webster's direction. It seems to me that the first order for President Reagan's safety is to terminate Webster and get a new head of the FBI. Secondly, I think the Chief of the Secret Service, Stuart Knight, should be replaced immediately. It seems to me there was gross and wanton negligence on his part when he knew that Reagan was going to go down this street, yet he did not have men posted, leaving the way open for an assassination. This smacks very much of the book which has now been written concerning the conspiracy to assassinate Lincoln.

Unquestionably, the President is going to be a target, because when a man is going to try to change the course of history in a country, he is naturally going to be marked by those radicals who are opposing him. And Lord only knows, this country has been so divided by the media, and so dominated by Rockefeller and his trilateralist group that none of us even begin to get the real truth of these matters.

I am taking the liberty of sending a copy of this letter to Nancy Reagan. After reading U.S. News and World Report, I am convinced that she is defininitely determined to protect her husband, and that the people in the White House who wanted him to overwork himself were definitely thwarted because of her determination and did not want to tangle with her. I feel that if anyone should be interested in seeing a change in these security matters, she should be. My wife joins me in this, and wishes me to so state, since she does not Mr. Michael Deaver April 23, 1981 Page 3

care to write. I realize that probably very few people will write, but having been a senator in the Kansas State Senate, I know that for every person who writes there are hundreds more who would write the same thing, but simply do not do it.

I could go on, but I feel that my point has been expressed many times to you. Again, I feel it is ridiculous that the FBI is spending its time on anti-trust matters, prosecuting business men for taking commissions to sell merchandise abroad, and doing everything it can to disrupt the country instead of directing all of its efforts to try to corral criminals like the man who tried to kill the President. And he was not even on their list! Further, I would venture to state that before it is all over, the Rockefeller-Hinckley money will get this attempted murderer off without any penalty other than some period of incarceration in a mental institution.





PRESIDENT-CITIZEN CONTACT vs. PRESIDENTIAL SECURITY

EXECUTIVE SUMMARY:

This paper points out that the one common thread linking all Presidential assailants is that they were aware of where the victim would be at some general time. This factor may be eliminated in part by the use of a number of brief unscheduled impromptu visits previously scouted by the White House advance staff on the sly. In addition to security considerations this paper posits a number of policy considerations in support of impromptu visits.

ABOUT THE AUTHOR:

Mark Wampler is the Vice-Chairman of the Iowa Railway Finance Authority, an instrumentality of the State of Iowa that is attempting tosolve the problems wrought by the bankruptcy of the Rock Island railroad. Previously Wampler has been employed on the staff of Iowa Governor Robert D. Ray, by numerous campaigns including the Baker for President Committee and was once a member of the Electoral College. Wampler is an active Republican and a theoretician which has earned him the distinction of being "the free spirit of the Iowa Republican Party" or "Republican without portfolio". The recent attack upon the President once again highlights the inherent conflict between the Presidential need for both public contact and security. A mechanism that may satisfy these divergent needs and at the same time contribute to the adoption of the President's economic package is a series of impromptu Presidential visits.

By the very nature of our political system it would be an absolute impossibility to eliminate from the President's schedule formal public appearances. The call for increased security that will surely come from some quarters will clash openly with the demand for access as usual by others. Yet it must be noted that the one common thread that links <u>all</u> Presidential assailants is their knowledge of the victim's whereabouts and movements. In fact it appears that some of the assailants stalked their prey over a period of time.

The American public expects and demands to see its elected leaders. Indeed, there has been valid criticism in the past that the phalanx of Secret Service agents and hordes of reporters that accompany the President on every foray from the White House act as a buffer to eliminate any meaningful contact between the President and the people. The size of the press corps is evident in the variety of photographs and video tapes available of what should have been a short and uneventful walk from a building to a car. While the very size of the press corps acts to inhibit any intellectual exchange between the President and the public it must be noted that in this instance the press through no fault of its own provided cover for the attacker.

Another problem with formal appearances is that time is spent on formalities and Presidential conversations are with union leaders, not the rank and file workers; Governors, not taxpayers; Mayors, not city street workers; Farm Bureau leaders, not struggling young farmers. This is not to say that such conversations are in any way wrong, but the possibility exists that such programmed conversations may erect a version of the Hollywood false front and mask the stark reality behind.

Let us now consider impromptu visits. Foremost, with no advance notice to the press and citizenry, the President with his security entourage would be safer than the average person. Secondly, to facilitate an impromptu visit only a small press pool would actually accompany the President on a particular jaunt and thus not interfere with a public dialog.

Perhaps an example would best serve to describe the type of visit I have in mind.

The President is flying from Washington to California. Present on Air Force One is a small press pool. Shortly after take off the President decides that he wants to break the flight with an impromptu visit. The advance men supply the President with a number of options that they have quietly scouted. The President decides to drop in at the Student Union of Simpson College in Indianola, Iowa.

Upon making the selection the President is provided with a briefing sheet on Simpson and his briefing books on student loan cuts and the draft registration. Somewhere before radio contact is established with the Des Moines tower, Air Force One assumes a false tail number supplied by the FAA. The Des Moines tower is thus unaware of exactly who is coming in until the Presidential Seal can be seen on the runway. Air Force One taxis to the Air Guard hangar where a small fleet of helicopters are ready for flight after a military order had been issued shortly before. Within minutes of landing in Des Moines the Presidential party is airborne for the twelve mile trip to Indianola, landing in Buxton City Park and on the grounds of Simpson College. The President strides across the street and into the Student Union, seating himself with a couple of students already discussing the state of the world over a pair of beers. After twenty minutes or so the President rises, shakes hands around the room with other students who have come in and joined the conversation. The President then returns to the waiting helicopters and leaves for Des Moines. Air Force One is waiting and is airborne for California only an hour after landing at Des Moines. Meanwhile the press is reporting President Reagan's frank discussion with a young opponent of the draft who is also concerned about the reduction in student loan funds.

The scenario could be repeated in a number of mutations that would provide the President with several little slices of American life: an urban coffee shop, farmers lines up to sell their grain at a Kansas elevator, a union hall, a Memorial Day celebration, a PTA meeting, a factory gate, a congregate meak site, etc.

President Truman went on a whirlwind tour of stump speeches to push his programs through the 80th Congress. President Reagan too should take his program directly to the American people and in so doing extend the "honeymoon" period. With the electronic media we now have this sales pitch could be made through a number of discussions with individuals and small groups which in turn would be conveyed to an audience of millions. The President's willingness to discuss his proposals one to one would underscore the role individuals can play in solving America's economic ills.

With the availability of such personal contact it would be difficult to begrudge or fault a little extra security during scheduled appearances.


The idea of impromptu visits is to heighten both security and individual contact. It is an ideal means by which the President may take his economic program directly to the people.







Dear Senator Baker:

The White House has sent your recent letter concerning your constituent, Vince Fodera, to the Treasury Department for a reply.

My inquiry has revealed that the Secret Service has received Mr. Fodera's plans for "The President's Visible Tunnel" from two prior sources. Representative Boner relayed them on May 7, and Mr. Fodera himself sent them directly to Secret Service Director H. Stuart Knight on April 6. At that time the plans were forwarded to the Service's Office of Protective Research so that the design might receive further study by their research and development engineers. As Assistant Director Snow wrote to Mr. Fodera at that time, the device was found to be operationally unsuitable because of its size and weight.

After the inquiries from you and Representative Boner, the Secret Service's technical experts have elaborated further upon their original opinion. They feel the device's weight and bulk would make it prohibitively expensive and unwieldy for operational use. Additionally, they feel that the possibility of the Tunnel's structural failure, brought on by malfunction, human error, or natural phenomena such as wind, could present a serious potential danger to protectees.

The Secret Service sincerely appreciates the effort and concern represented by Mr. Fodera's invention and regrets that they are unable to use his idea.

If I may be of further assistance in this or any other matter, please do not hesitate to call on me.

Nashville Man Designs Tunnel

For President

By BARRY BRYANT Business News Writer

Vince Fedora is at it again.

The inventor of GG Ball (GG stands for Great Girls) has designed a tunnel to protect the President of the United States from bullets of would-be assassins.

"I'm amazed nothing like this has ever been done," said the 51-year old Nashville artist and inventor.

"The President's Visible Tunnel" is a series of clear plexiglass sections that connect to form a protective barrier for a president as he leaves a building for his limosine.

The 1¾ inch-thick plexiglass will stop a .44 caliber magnum bullet fired at point-blank range, Fedora said.

Fedora hasn't actually built a tunnel, but it took the him only a couple of days to whip up a model and send photographs and specifications to the White House for examination.

""Tve had the idea for some time," he said. When Lynette Fromme tried to shoot President Ford outside his limosine, it occured to Fedora that a president could use the extra protection.

TA bulletproof vest wouldn't protect his head. Why not a tunnel?

"Because of the incident Monday (the attempt on President Reagan's life), it revitalized the idea. I immediately built this model, and sent a copy to the White House," he said.

The sections can be rolled out and quickly linked together. Each section is four feet long and seven and a half feet high, with a five-foot passageway.

* Sound amplifiers throughout the tunnel would enable the president hear questions and talk to the crowd outside in a normal voice, Fedora said. * He admits that might cramp the president's style. "It's unfortunate that that is our society, but more it is important at this time is to protect our president."

The estimated cost per section is \$7,000 to \$8,500.

Inventing has always been a passion for Fedora. His GG Ball game drew about 150 people
