Patricia Kearney is a native of New Bedford, Massachusetts. Kearney graduated from Simmons College in Boston, and recieved an M.Ed degree from Tufts University in nutrition. She worked as a senior nutritionist at Brigham and Women's Hospital in Boston She also lectured at the Harvard Medical School and the Harvard School for Public Health.

Ms. Kearny served as Associate Director of the White House Office of Private Sector Initiatives from 1984-1987. She worked in a similar capacity as an assistant to the Secretary of Agriculture. She was also a nutrition advisor and assistant to the Assistant Secretary for Food and Consumer Services.

Kearney left the White House to start her own public relations firm, PMK Associations. She served as Deputy Director of Communications for the Republican National Convention and worked in communications for the 1988 Bush/Quayle campaign. In late 1988, she was designated as the transition point of contact for the Department of Agriculture.
