Biography

Stephen H. Galebach worked in the Office of Policy Development beginning as a senior staff member on legal policy under Michael Uhlmann. He moved up to a Deputy Assistant Director by the time he left in 1986. Galebach focused on family/social issues such as abortion, family policy, and school prayer.

Stephen Galebach was born in 1952 and grew up in Lancaster, Pennsylvania.

Prior to his 1974 graduation from Yale University, he was president of the student body Republican club. After leaving college, he served as a platoon commander in the Marine Corps Reserves from 1974-1976. He later entered Harvard Law School and earned a law degree.

In 1981, writing in the *Human Life Review*, Galebach argued that the 14th Amendment, which gives Congress authority to force the states not to deprive "any person" of life without due process of law, provided a constitutional basis for a federal law restricting abortion. The abortion bill that he drafted based on this reasoning was introduced in Congress in January 1981, but failed to pass.

While his article and ideas were being used by pro-life legislators, Galebach took a position as an attorney with the Washington, DC-based Christian Legal Society. He left the Christian Legal Society in 1982 to serve in the Reagan White House.

Galebach is currently an attorney practicing in Masschusetts.
