## **Biography**

Todd Foley, a detailee from the Department of Defense, began work in the White House Office of Public Liaison in June 1983. Foley assisted former Congressman John Rousellot with the public liaison activities promoting passage of the MX missile legislation. After Rousellot left Public Liaison in September 1983, Foley's detail to the White House continued and he was assigned wider responsibilities, particularly to the business community.

Foley was promoted during his time at the White House, starting as a Staff Assistant to Rousellot, becoming a Senior Staff Assistant in January 1986, Deputy Associate Director in August 1986, and finally appointed Associate Director in June 1988. At the time of his appointment, Foley's portfolio included small business, as well as taxes, trade, budget, economic policy, labor, and transportation.
