### **Biography**

A California native, Robert Holmes Tuttle graduated from Stanford University and received his MBA from the University of Southern California

Tuttle began his in the public sector when he joined the White House staff in 1982 as Special Assistant to President Reagan. In 1985, President Reagan appointed him Director of Presidential Personnel, a position he held until the end of the administration.

Tuttle served as U.S. Ambassador to the Court of St. James's from July 2005 to February 2009. A businessman with extensive experience in the private sector, Ambassador Tuttle is Co-Managing Partner of Tuttle-Click Automotive Group. By Presidential Appointment, Ambassador Tuttle served on the Board of Directors of the Woodrow Wilson International Center for Scholars for four years. As of 2021, Tuttle serves as Co-Chairman of the Pacific Council on International Policy and as a member of the Board of Directors of the National Endowment for Democracy.
