Biography

Mr. Uhlmann is a native of Washington, DC. Uhlmann graduated from Yale University and went on to receive a doctorate in government from Claremont Graduate School. He received his law degree from the University of Virginia Law School.

Uhlmann served as Assistant Attorney General for Legislative Affairs in the Justice Department during the Ford Administration. He was part of President-Elect Reagan's transition team as Associate Director for legal and administrative agencies. He continued with the Reagan Administration as the Special Assistant to President Reagan working on legal policy issues within the Office of Policy Development. He served in the first administration.

Uhlmann left the White House to join Pepper, Hamilton and Scheetz, a Washington, DC law firm. He was involved in the Bush/Quayle 1988 presidential campaign advising on legal policy and a member of both the Advisory Committee for Lawyers for Bush/Quayle and the Steering Committee for Catholics for Bush.

In 1988 he was designated as the transition office contact for the Justice Department on behalf of the Bush/Quayle transition team.

Michael M. Uhlmann is currently professor of government in the department of politics and policy at Claremont Graduate University and Claremont McKenna College. Prior to teaching at Claremont, Dr. Uhlmann was a senior fellow at the Ethics and Public Policy Center, Vice President for Public Policy Research at the Bradley Foundation in Milwaukee, and taught at the George Mason University Law School.
