Biography

Patricia Mack Bryan was born in Philadelphia, PA on July 7, 1955. She graduated from Gettysburg College (B.A., 1977) and Harvard Law School (J.D., 1980). After obtaining her law degree, she became an associate attorney with the Washington, DC law firm Jones, Day, Reavis & Pogue. In 1983, she took a position in the Justice Department's Office of Legal Policy.

Ms. Bryan joined the White House Counsel's Office in June 1987. She remained in the Counsel's Office into the George H. W. Bush administration, resigning in September 1989. Bryan later resumed work in the Department of Justice, before suspending her career to devote more attention to her family. In 2001 she returned to the workforce, as the first woman to serve as Deputy Legal Counsel for the U.S. Senate.

Bryan's files from her time in the George Bush White House are at his presidential library in College Station, Texas.
