# **Scope and Content Note**

#### Note

The Judicial Selection Files consist of a filing system originated and maintained by the Counsel to the President Office primarily for the first Reagan Administration. These files contain information on judicial, United States Attorney and United States Marshal candidates. The material was filed at the White House by numbered Appeals Courts, and U.S. District Courts alphabetically by state. The Library has maintained this filing arrangement including the often empty folders marking the states and districts. Similar records on these type of candidates from the second administration are maintained in individual collections of Counsel's Office staff members, particularly <u>Alan Raul</u> and <u>Patricia Mack Bryan</u>.

This collection also includes a small set of subject file and miscellaneous information on judicial selection which covers all eight years.

The Judicial Selection File is arranged in four series. They are: SERIES I: U.S. Courts of Appeals, 1981-1984; SERIES II: U.S. District Courts, 1981-1984; SERIES III: Other Courts, 1981-1984; and SERIES IV: Judicial Selection, 1981-1989.
