## **Biography**

Jonathan "Jock" Scharfen is a retired Marine Corps officer, government official, businessman and lobbyist.

Scharfen received his B.A. from the University of Virginia, his J.D. from the University of Notre Dame, and his LL.M. from the University of San Diego. He also attended the U.S. Army War College in Carlisle, Pennsylvania where he studied national security strategy.

Scharfen retired from the United States Marine Corps in August 2003 after 25-years of active duty service. He held a number of leadership and legal positions in the Marines. From 1978 to 1983 he served as a Marine infantry officer in various leadership billets. He served as trial counsel and staff judge advocate for various commands at Marine Corps Base, Camp Pendleton, from 1988 to 1991, and deployed with the 5th Marine Expeditionary Brigade for Operation Desert Storm. From 1992 to 1995, Scharfen served as Special Counsel, Environmental Law, Western Area Counsel Office. He then served as Associate Counsel, Land Use, Office of the Counsel for the Commandant of the Marine Corps. In 1998 he was selected to command Company A, Marine Security Guard Battalion, which had oversight of twenty US Embassy and Consulate Marine Security Guard Detachments throughout the U.S. European Command's area of responsibility, including Central Asia. He was responsible for the opening of twelve new security detachments in addition to the twenty existing detachments.

As part of Scharfen's Marine Corps tours, he served on the National Security Council in the Reagan Administration, 1985-1988. He was a legal fellow until 1986 and then returned as Staff Counsel and Assistant Legal Advisor until 1988. In 2000 he returned to the National Security Council staff as Deputy Legal Advisor and Director.

Just after retiring from the Marine Corps in August 2003, Scharfen served as Chief Counsel/Deputy Staff Director of the House International Relations Committee (HIRC) until July 2006.

Scharfen was appointed as the Deputy Director of U.S. Citizenship and Immigration Services (USCIS) on June 22, 2006 by USCIS Director Emilio Gonzalez. The Deputy Director acts as a Chief Operating Officer of the agency and oversees the day-to-day operations of the agency. Scharfen was responsible for managing all USCIS Directorates, including all Headquarters office components. He then served as Acting Director of USCIS after Gonzalez resigned in April 2008. He was nominated by President George W. Bush to the post of Director of USCIS, but the Senate never acted on his nomination.

After leaving government service, Scharfen worked in corporations, mostly with defense contractors such as Northrup Grumman and PAE-TS. In 2019, Scharfen joined Cargill, Inc. where he is currently vice-president of global government relations.

Scharfen is married to the former Diane Pauahi Lee and has three children.
