Biography

Biography

Shannon Ann Fairbanks is a former government official and non-profit executive.

Fairbanks was born in Newton, Massachusetts on March 24, 1941. She attended Newton College of the Sacred Heart, an all -women's liberal arts college in Newton, MA. Newton College was later merged with Boston College in 1974.

Prior to returning to graduate school, Fairbanks worked for non-profits in Florida, Newport, Rhode Island, New York City, and Washington, DC. She worked mostly in human support services as a Project Manager for the Navy Relief Society, as Project Director for the 125th Street Program (pre-job training for Hispanic Americans) and as the Vice President of the Family and Child Services of Washington, DC.

From 1975-1979, Fairbanks attended graduate school at Columbia University achieving a double master's degree in public policy and planning for urban and regional markets. While at Columbia, Fairbanks completed multiple internships. These included a program to utilize the United Mine Workers pension fund for financing coalfield housing in Appalachia; organizing a successful coalition lobby to maintain Congressional commitment to low-income housing and as Assistant to the Deputy Director to the Neighborhood Reinvestment Corporation. In this last position, Fairbanks initiated a partnership reinvestment program between non-profit Neighborhood Housing Services and six large national insurance companies.

In the fall of 1979, Fairbanks became the Director for the WEAL National Economic Equity Awards Dinner honoring corporate women vice-presidents. She organized the participation of 28 major companies which resulted in a large increase for the dinner proceeds.

For most of 1980, Fairbanks was a Securities Industry Examiner working at the National Association of Securities Dealers. She was responsible for examination of the practices and procedures of over-the-counter securities firms in the mid-Atlantic region. Late in the year, she was granted a leave to the 1980 Reagan/Bush for President campaign.

In August, she became a policy analyst for the Campaign in the research and policy division. Post-election she joined the President-Elect Transition team as the Deputy Director for the Housing and Urban Development Transition Team responsible for the

Federal Home Loan Bank Board Transition Team.

Fairbanks was appointed to the Office of Policy Development as Senior Policy Analyst and began on the first day of the Reagan Administration, January 21, 1981. Her general responsibilities were for housing and mortgage finance, education and veterans' policy. The majority of her work was based in housing issues with a focus on mortgage financing - both outside the traditional sources and Savings and Loans institutions.

Fairbanks left the White House in April 1983 to be the Assistant to the Director of the Federal Home Loan Bank Board where she eventually became the Staff Director of the FHLBB. Fairbanks remained at FHLBB into the George H.W. Bush Administration. Fairbanks was at FHLBB when the Lincoln Savings & Loan and other S&L scandals erupted in the late 1980s. She testified before Congress on these events and lost her position when the Federal Home Loan Bank Board was eliminated by the Financial Institutions Reform, Recovery, and Enforcement Act of 1989 (FIRREA).

Since leaving public service, Fairbanks has been in private investment and was the Director for Fairbanks Investment Funds Holdings. She was on the Board of Directors for Invectys, a Houston company working on innovative therapeutic anti-cancer treatments. She is also the Chairman of the Board for Layalina Productions, a media company founded by her late husband, Richard Fairbanks III. It is committed to bridging the gap between the Arab world and the United States through documentaries, films and television programs.

Shannon O'Connor and Richard Fairbanks were married in 1962 right out of their respective colleges and Richard Fairbanks was immediately deployed with the U.S. Navy. He left the Navy in 1966 and attended Columbia University Law School. He graduated in 1969 and after two years in a private law firm began his public service career. Fairbanks worked in the Nixon Administration for William Ruckleshaus at the fledging Environmental Protection Agency and eventually was on the Nixon White House Domestic Policy staff.

After leaving the White House in 1974, Richard Fairbanks founded his own Washington, DC law firm, then he also joined the Reagan/Bush President-Elect Transition team for Domestic Policy. In 1981, he was appointed to the State Department as Assistant Secretary of State for Congressional Relations. He eventually was appointed an Ambassador-at-Large and worked mainly on U.S.

relations in the Middle East. He remained active in public service appointed to several advisory task forces by President George H.W. Bush. After 9/11, Richard Fairbanks founded Layalina Productions. He died in 2013 after a short illness.

The Fairbanks have two sons, and six grandchildren. Shannon Fairbanks now resides in West Palm Beach, Florida.

Scope and Content Note

Scope Note

This collection was transferred to the Library with little organization or evident filing system. Several attempts have been made to organize material that was found loose and unfoldered in the containers transferred to the Library. Fairbanks worked in the President-Elect's transition office in late 1980 and early 1981. She appears to have brought with her and used some of this material at the White House.

Fairbanks' collection is focused almost exclusively on housing and mortgage financing issues from the early 1980s. She does have some material on public housing and lower-income problems. But the bulk of the material is regarding the difficulties of mortgage financing in the early 1980s (15-20 percent interest rates) and possible creative ways to finance mortgages to ease access to housing financing.

It also includes material regarding savings and loans. This covers insurance requirements for thrift banks, regulations, and legislation easing some regulations on savings and loans.

This collection includes a large amount of published material, news clippings, and reports. Where possible we have tried to allow subject access to this material. The remaining publications can be found in Series V: Publications and Reports.
