Biography

Wendy Borcherdt (April 12, 1936-) is a prolific volunteer, management specialist and civil servant.

Wendy Borcherdt is a native California who attended Stanford University and graduated with a degree in political science and English in 1958.

Mrs. Borcherdt has been involved with many volunteer organizations. During the 1960s she was international director, Association of Junior Leagues, Inc.; president, Junior League of Los Angeles, Inc.; president, Symphonians to the Junior Philharmonic; president, Stanford Women's Club of Los Angeles County; member, City of Los Angeles Economic Advisory Council. Beginning in 1974, her long association with the Hoover Institution on War, Revolution, and Peace at Stanford University began as a member of the finance committee. Also in the 1970s she was a vice chairman and trustee of the Independent Colleges of Southern California.

She has been active in Republican Party politics at the local, State, and national levels for many years. She was a volunteer in every Ronald Reagan political campaign from 1976 to 1984. In 1979-1980 she was a staff member of the 1980 Presidential Campaign, as regional finance director to the Reagan for President Committee in California. After the election, she assisted with the Inaugural ceremonies.

Even during the campaign, Borcherdt continued volunteer work as a director of the Pacific Legal Foundation and director of Town Hall of California, a forum dedicated to civic education and to the discussion of public questions. In the late 1970s-1980, Brocherdt was president of an organizational management teaching and consulting firm, Training for Effective Management. She was an associate with Teren and Co. of New York and Virginia Beach in 1976-1977.

Borcherdt joined the White House Presidential Personnel staff in February 1981, with responsibilities for recruiting and selecting women for Executive Branch positions, and recruiting ambassadorial candidates. In September 1981 she moved to the Office of Public Liaison, as the first Public Liaison person specifically assigned to women and women's groups. Borcherdt left the White House staff in September 1982, shortly before being nominated as Deputy Under Secretary of Education for Intergovernmental and Interagency Affairs.

In 1984, Borcherdt left service with the Reagan Administration to become president of the Citizens for the Republic, a fund-raising and conservative education non-profit founded by President Reagan in the run-up to his 1980 campaign. The CFTR had become inactive but was revived for the second Reagan presidential campaign and still exists today. Returning to public service in 1985, Borcherdt was on the founding Board of Directors for the United States Institute for Peace.

Borcherdt continued her involvement with Republican candidates, but her longest and most significant association after leaving public service has been with the Hoover Institute. She was appointed to the Board of Overseers and is now a Distinguished Overseer for the Board.

Borcherdt has two children and lives in McLean, Virginia.

Scope and Content Note

The Reagan Library received from the White House a single set of Borcherdt files that document her time in Public Liaison with a very small amount of documentation regarding her position within the Office of Presidential Personnel. The Library maintains this material as one collection.
