Biography

Biography

David Waller was born in Decatur, Illinois. He is a graduate of Denison University, Granville, Ohio (1970), where he was named Economics Fellow and was inducted into Omicron Delta Kappa Leadership Honorary and Omicron Delta Epsilon Economics Honorary. Following undergraduate school and duty in the Army Reserves, Mr. Waller graduated first in his class from the University of Tulsa, College of Law (J.D., with honors) in 1973.

Before serving in the Reagan Administration, Mr. Waller practiced law from 1978 to 1981 at the Washington D.C. firm of Hogan and Hartson (the largest Washington-based law firm, now 'Hogan Lovells').

He was recruited directly from law school into the Attorney General's Honor Program at the U.S. Department of Justice, Washington, D.C., where he worked from 1974 to 1978 as a trial attorney representing the interests of the U.S. in federal courts around the country.

Mr. Waller served from 1981 to 1986 as Senior Associate Counsel to the President at the White House.

In 1986, Mr. Waller was nominated by President Reagan, and confirmed by the U.S. Senate, as Assistant Secretary of Energy for International Affairs, the sub-cabinet position he held through 1989. In that capacity he was the Secretary of Energy's chief advisor and spokesman on international energy policy and emergency preparedness. He represented the U.S. at various multinational agencies, including the International Energy Agency of the OECD, headquartered in Paris, and the IAEA in Vienna. He was responsible for formulation and implementation of bilateral energy relations and programs with foreign governments and, in this connection, was engaged in extensive foreign travel. Contacts were at the ministerial level and often included participation in private meetings with Heads of State/Government. Additionally, he was liaison with embassies in Washington, received foreign delegations, and testified before various Congressional committees.

In recognition of his work as Assistant Secretary, Mr. Waller was presented, in 1989, the Secretary's Award — the highest honor given by the Department of Energy — for outstanding leadership. Thereafter, in 1990, the Secretary presented him with the

Superior Achievement Award, in special recognition of his achievements in the international arena.

From 1993 through 2011, Mr Waller served as Deputy Director General and head of management of the International Atomic Energy Agency (IAEA). Throughout that time he was the highest ranking American in the UN agencies based in Vienna, Austria.

David Waller served from 1981 to 1986 as Senior Associate Counsel to the President at the White House. The Office of Counsel to the President functions as a small law firm that advises and represents the President and senior White House staff regarding all official legal matters.
