Biography

Phillip D. Brady, born May 20, 1951 in Pasadena, CA, is an attorney, public official serving in both the Reagan Administration and the George H.W. Bush Administration and an association president.

Phillip Brady holds a B.A. degree from the University of Notre Dame in Indiana and a J.D. degree from the School of Law Loyola University in New Orleans.

Brady first practiced law as an associate in the law firm of Spray, Gould and Bowers in Los Angeles, 1976-1978. He began his first public service as a deputy attorney general, California Department of Justice, 1978-1979.

Moving to Washington, Brady worked as the legislative counsel for California Representative Daniel E. Lungren from 1979 to early 1981.

Starting in 1981, Brady began a long association with the Reagan and George H.W. Bush Administrations beginning with an appointment as ACTION Region IX regional director from 1981-1982. Moving to INS, Brady was Director for Congressional and Public Affairs, Immigration and Naturalization Service, 1982-1983.

Mr. Brady served several posts at the Department of Justice: Acting Assistant Attorney General for the Office of Legislative and Intergovernmental Affairs, 1984-1985 and Associate Deputy Attorney General, 1983-1984.

In 1985, Brady began work at the White House as Deputy Assistant to the Vice-President Bush, 1985-1988 where he was heavily involved with the "War on Drugs," assisting the Vice President with coordinating agency and military responses to the efforts to stop the flow of drugs across the southern borders of the United States. Brady moved to the President's staff in 1988-1989 as Deputy Counsel to the President.

His first position in the George H.W. Bush Administration was Deputy Assistant to the President and Director of Cabinet Affairs at the White House in Washington, DC, January 1989-June 1989. In June 1989, Brady was appointed General Counsel to the Department of Transportation. He remained there until December 1990. In 1991, Brady became the White House Staff Secretary and remained there until the end of the Bush Administration.

Leaving public service, Brady began working with automotive trade associations. He served six years as vice president and general counsel for the American Automobile Manufacturers Association. Brady then became the National Automobile Dealer's Association (NADA) chief operating officer of industry affairs for nearly three years and finally served as NADA's president from 2001-2012.
