Biography

Biography

Danny Julian Boggs is an American attorney and a Senior United States Circuit Judge of the United States Court of Appeals for the Sixth Circuit.

Born in Havana, Cuba (October 23, 1944), and raised in Bowling Green, Kentucky, Boggs attended College High School in Bowling Green, where he was a member of the debate team that won the 1959 Kentucky state debate championship. He received a B.A. from Harvard University in 1965 and graduated from the University of Chicago Law School in 1968. At the University of Chicago, he won the Hinton Moot Court Competition and was an editor of the University of Chicago Law Review.

Boggs began his career with an academic position as a Bigelow Fellow and instructor at the University of Chicago Law School from 1968 to 1969. Later, he served in a variety of roles in Kentucky state government: first as the deputy commissioner of the Kentucky Department for Economic Security from 1969 to 1970, then as legal counsel and administrative assistant to Governor Louie Nunn from 1970 to 1971. Switching to the legislative branch, he was legislative counsel and assistant to the minority leader of the Kentucky State House of Representatives in 1972. Then he became involved in Republican politics as an attorney for the Kentucky Republican Campaign in 1972, and finally as deputy campaign director for the Nunn for Governor Campaign in 1979.

When not serving in the state or federal government, Boggs engaged in private practice in Frankfort, Kentucky, in Bowling Green, Kentucky, and then 1979 to 1981 in Washington, D.C.

Boggs started a career in federal government as an attorney for the Department of Commerce in 1973. From 1973 to 1975, he served, alongside future Chief Judge of the United States Court of Appeals for the Seventh Circuit, Frank Easterbrook, and future Secretary of Labor in the Clinton Administration, Robert Reich, as assistant to the United States Solicitor General, at the time, Robert Bork.

Boggs began his association with the Reagan Administration working in the President-Elect's transition office focusing on energy policy. Boggs then served as senior policy analyst, deputy director and special assistant to the President in the Office of Policy Development with responsibilities for energy issues from 1981 to 1983. He left the White House for an appointment with the Department of Energy.

Boggs had prior energy issue experiences, he served as assistant to the Chairman of the Federal Power Commission from 1975 to 1977, then as deputy minority counsel for the United States Senate Committee on Energy and Natural Resources (1977-1979). Boggs was appointed Deputy Secretary of the United States Department of Energy, serving from 1983-1986. He received the Department of Energy Secretary's Gold Medal.

On January 29, 1986, Boggs was nominated by President Reagan to the United States Court of Appeals for the Sixth Circuit to take a new seat authorized by 98 Stat. 333. He was confirmed by the Senate on March 3, 1986, and received his commission on March 25, 1986. From 2003 to 2009, Boggs served as Chief Judge of the Sixth Circuit. During his judicial career, he was variously Secretary, Vice-Chair and Chair of the Appellate Judges Conference of the American Bar Association from 2001 to 2002, and a member of the Judicial Conference of the United States from 2003 to 2009. Boggs was on the short list of President George W. Bush's candidates for the Supreme Court. Judge Boggs assumed senior status on February 28, 2017.

Scope and Content Note

Danny J. Boggs had the "energy" portfolio within the Office of Policy Development. This grew to include Department of Energy reorganization efforts, natural resources, agriculture, and science and technology issues. His personal interest was in biomedical engineering and gene splicing.

Boggs basically created his own filing series and the Library has maintained this original order. He grouped subjects by energy, natural resources, agriculture, the environment, working groups, global issues, and the National Aeronautics & Space Administration. His collection included administrative material which has been divided up into a group of series starting with Series VIII: Memoranda. Boggs also had odd subjects not fitting his devised subject series. The Library has placed these unique subject folders mostly in the Administrative series. Most of these individual subject folders involved responding to a request from Edwin Harper, the Assistant to the President for Policy Development, and usually involved working across White House and agency offices.

Boggs retained material he worked with or created within the Office of the President-Elect, 1980. We have placed this as the last series in this collection as the material is not Presidential and is not subject to the Freedom of Information Act. The material can be substantive, especially for how the Reagan Administration approached energy policy from the first days of the Administration.
