### **Board Description**

Executive Order 12334 established the President's Intelligence Oversight Board (PIOB) on December 4, 1981. Part of the White House Office, Executive Office of the President, the PIOB consists of the Chairman who is also a member of the President's Foreign Intelligence Advisory Board (PFIAB) and two other members. The PIOB's responsibilities include informing the President of unlawful intelligence activities, reviewing Intelligence Community internal guidelines, and conducting investigations to carry out these functions.
